THE LATIN SCHOOL OF CHICAGO

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to THE LATIN SCHOOL OF CHICAGO, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Decorative Fence(s) on the public right-of-way adjacent to its premises known as 45 W. North Blvd..

Said Decorative Fence(s) at Dearborn Street measure(s):

One (1) at sixty-eight point one (68.1) feet in length, and nine (9) feet in width for a total of six hundred twelve point nine (612.9) square feet.

Said Decorative Fence(s) at Dearborn Street measure(s):

One (1) at eighty-two point one (82.1) feet in length, and nine point three (9.3) feet in width for a total of seven hundred sixty-three point five three (763.53) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1100704 herein granted the sum of zero (\$.00) per annum in advance.


A 25% penalty will be added for payments received after due date.


