**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all C1-2 Neighborhood Commercial District symbols and indications as shown on Map No. 9-G in the area bounded by

North Ashland Avenue; a line 48.78 feet north of and parallel to West Waveland Avenue; the alley next east of and parallel to North Ashland Avenue; West Waveland Avenue

to those of B2-3 Neighborhood Mixed-Use District, and a corresponding use district is hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.
