ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1: Title 17 of the Municipal Code of Chicago, Chicago Zoning Ordinance, is amended by changing all the M1-2 Limited Manufacturing / Business Park District symbols and indications as shown on Map No. 8-F in the area bounded by:

A line 704 feet south of and parallel to the south line of West 33rd Street; the alley next east of and parallel to South Parnell Avenue; line 729 feet south of and parallel to the south line of West 33rd Street; South Parnell Avenue

to those of a RS-3 Residential Single-Unit (Detached House) District, which is hereby established in the area described.

SECTION 2: This ordinance shall take effect upon its passage and due publication.




