LOADING ZONE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as loading zones for the distances specified, during the hours specified:

WARD LOADING ZONES:

- 1 N. Bell Avenue (west side) from a point 30 feet north of W. North Avenue to a point 25 feet north thereof: No Parking Loading Zone, 7:00AM to 6:00PM, Monday through Friday, Tow Zone -- 11-03666737 [O2011-4871]
- 2 S. Michigan Avenue (west side) from a point 660 feet north of E. 16th Street to a point 25 feet north thereof: No Parking Loading Zone, 11:00AM to 7:00PM, All Days -- 11-04095675 [O2011-7600]
- 3 S. Calumet Avenue (west side) from a point 20 feet south of E. 43rd Street to a point 50 feet south thereof: Reserved Disabled Parking 2% -- 11-04101882 [Or2011-879]
- 30 W. Belmont Avenue (south side) from a point 185 feet west of N. Laramie Avenue to a point 23 feet west thereof: 15 Minute Loading Zone, use flashing lights, Tow Zone after 15 minutes; 11:00AM to 7:00PM -- 11-03741557 [O2011-5490]
- 37 W. Thomas Street (south side) from a point 55 feet west of N. Kilbourn Avenue to a point 40 feet west thereof; W. Thomas Street (south side) from a point 127 feet west of N. Kilbourn Avenue to a point 25 feet west thereof: No Parking Loading Zone, 7:00AM to 5:30PM Monday through Friday and 7:00AM to 3:30PM Saturdays, Tow Zone -- 11-03716215 [O2011-6174]
- 50 N. Artesian (east side) from a point 30 feet south of W. Rosemont to a point 25 feet south thereof: Reserved Disabled Parking 2% [O2011-9710]

WARD AMEND LOADING ZONES:

Wellington Avenue and inserting in lieu thereof: 20 feet -- 11-02875850 [O2011-5562]
