ORDINANCE COSMO MART Acct No. 250790 - 3 Permit No. 1092147

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to COSMO MART, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, five (5) Awning(s) projecting over the public right-of-way adjacent to its premises known as 6301 S. Ashland Ave..

Said Awning(s) at W. 63RD ST measure(s):

Two (2) at eight point seven five (8.75) feet in length, and two point three three (2.33) feet in width for a total of forty point seven eight (40.78) square feet.

Said Awning(s) at W. 63RD ST measure(s):

One (1) at seven point one (7.1) feet in length, and two point three three (2.33) feet in width for a total of sixteen point five four (16.54) square feet.

Said Awning(s) at CORNER OF W. 63RD ST & S. ASHLAND AVE measure(s):

One (1) at eight point five (8.5) feet in length, and four (4) feet in width for a total of thirty-four (34) square feet.

Said Awning(s) at S. ASHLAND AVE measure(s):

One (1) at eight point five (8.5) feet in length, and two point three three (2.33) feet in width for a total of nineteen point eight one (19.81) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1092147 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.


Authority herein given and granted for a period of five (5) years from and after 05/09/2010.
