## ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois authorized to exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the Cook County Board of Commissioners has enacted the Real Property Assessment Classification Ordinance, as amended (the "Classification Ordinance"), which establishes the Class L property tax classification to encourage the preservation and rehabilitation of certain historically and architecturally significant buildings, which will enhance the general character of real estate in the county and contribute to the economic well-being of the county by increasing the level of economic activity, increasing employment opportunities and contributing to the long-term growth of the real property tax base; and

WHEREAS, VHNA Acquisition, L.P., a Delaware limited partnership or its successor in interest (the "Owner"), is the owner of the historic building known as the Old Dearborn Bank Building (the "Building") located at 203 N. Wabash Avenue in Chicago, Illinois, as more precisely described in <u>Exhibit 1</u> attached hereto and hereby made a part hereof (the land and improvements thereon being herein referred to as the "Project Real Estate"); and

WHEREAS, City Council of the City (the "City Council") adopted an ordinance on June 4, 2003 designating the Building as a Chicago Landmark pursuant to the criteria then established in Section 2-120-620 of the Municipal Code of Chicago, and such designation as a Chicago landmark meets the definition of landmark pursuant to the Classification Ordinance; and

WHEREAS, the Owner proposes to rehabilitate the Building (referred to herein as the "Project") thereby preserving the historic building, increasing employment opportunities in the area and contributing to the long-term growth of the real property tax base; and

**WHEREAS**, the Owner anticipates using the Building for hotel purposes (the "Use") after the Project is completed; and

WHEREAS, it is anticipated that the Project may require a transfer of a beneficial interest in the Owner to one or more entities who will receive an allocation of federal historic rehabilitation tax credits ("Tax Credit Investors"); and

WHEREAS, the Owner has applied to the Office of the Assessor of Cook County, Illinois (the "Assessor"), for designation of the Project Real Estate as a Class L classification eligible for certain real estate tax incentives pursuant to the Classification Ordinance; and

WHEREAS, pursuant to the Classification Ordinance, the Class L classification is available to real estate which is to be used for commercial or industrial purposes and which (1) is a Landmark (as defined in Section 1 of the Classification Ordinance); and (2) has undergone Substantial Rehabilitation (as defined in Section 1 of the Classification Ordinance), which constitutes an investment by the owner of at least 50 percent of the building's full market value as determined by the Assessor in the assessment year prior to the commencement of the Substantial Rehabilitation; and the Class L incentive shall apply to the building only, except that if the entire building has been vacant and unused for at least 24 continuous months prior to the filing of the eligibility application with the Assessor, the land upon which the building is situated shall be eligible for the incentive; and WHEREAS, Section 2 of the Classification Ordinance requires that, in connection with the filing of a Class L eligibility application with the Assessor, an applicant must obtain from the unit of local government in which the real estate is located, an ordinance or resolution which expressly states that the local government: 1) has determined that the incentive provided by Class L is necessary for the Substantial Rehabilitation of the property; 2) supports and consents to the granting of the incentive; and 3) has reviewed and accepted its Preservation Commission's (as defined in Section 1 of the Classification Ordinance) written recommendation of the project for the Class L incentive, specifying the project budget and proposed scope of the work, which meets or exceeds the Standards of the United States Department of the Interior for Rehabilitation, Preservation, Restoration, and Reconstruction of historic properties; and

WHEREAS, the City is a Certified Local Government as defined in Section 1 of the Classification Ordinance and has established the City of Chicago Commission on Chicago Landmarks (the "Landmarks Commission"), and such Landmarks Commission is a Preservation Commission (as defined in Section 1 of the Classification Ordinance); and

**WHEREAS**, on April 5, 2012, the Landmarks Commission issued a written recommendation of the Project to the City Council; recommending that the Project be approved by the Assessor for the Class L incentive, a copy of which is attached hereto as **Exhibit 2** and hereby made a part hereof; and

WHEREAS, the Project Real Estate shall have been occupied and used for the 24month period prior to the filing of the Class L eligibility application with the Assessor, making the Class L incentive applicable to the Building only; and

WHEREAS, the Department of Housing and Economic Development of the City ("DHED") has reviewed the proposed Project, and the Landmarks Commission has determined that it meets the necessary eligibility requirements for Class L designation, and hereby recommends to City Council that the City expressly determine by ordinance that: 1) the incentive provided by Class L is necessary for the Substantial Rehabilitation of the Project Real Estate; 2) the City supports and consents to the granting of the incentive; and 3) the City has reviewed and accepted the Landmarks Commission's written recommendation of the Project for the Class L incentive, specifying the Project budget and proposed scope of the work, and specifying that the Project meets or exceeds the Standards of the United States Department of the Interior for Rehabilitation, Preservation, Restoration, and Reconstruction of historic properties; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** The above recitals are hereby expressly incorporated as if fully set forth herein.

**SECTION 2.** The City hereby determines that the incentive provided by Class L is necessary for the Substantial Rehabilitation of the Project Real Estate.

**SECTION 3.** The City hereby expressly supports and consents to the granting of the Class L incentive.

**SECTION 4.** The Project is anticipated to be completed by March, 2014. The Commissioner of HED (the "Commissioner"), or a designee of the Commissioner (together with the Commissioner, an "Authorized Officer"), shall have discretion to extend any of the construction commencement and completion dates by issuing a written extension letter in

response to a written request from the Owner. To the extent that the Project Real Estate is not rehabilitated, used or maintained during the term of the Class L incentive in a manner which is substantially consistent with the approved Project or Use, as determined by the Authorized Officer, the Authorized Officer is hereby authorized to take such steps as may be necessary and appropriate to withdraw the City's support and consent to the Class L incentive, which may cause the Class L certification to be terminated or revoked.

**SECTION 5.** The City has reviewed and hereby accepts the Landmarks Commission's written recommendation of the Project for the Class L incentive, which specifies the Project budget and proposed scope of the work, and which specifies that the Project meets or exceeds the Standards of the United States Department of the Interior for Rehabilitation, Preservation, Restoration, and Reconstruction of historic properties, a copy of which is attached hereto as <u>Exhibit 2</u> and made a part hereof.

**SECTION 6.** The Authorized Officer is hereby authorized to deliver a certified copy of this ordinance to the Assessor and to furnish such additional information as may be required in connection with the filing of the application by the Owner with the Assessor for Class L designation of the Project Real Estate.

**SECTION 7.** The Authorized Officer is hereby authorized to enter into and execute such instruments and agreements, and perform any and all acts as shall be necessary or advisable in connection with the Project, including such other terms and conditions as may be approved in connection with the Project by the Authorized Officer. The Authorized Officer is hereby authorized to approve minor changes in the scope of work and budget delineated on (Sub) Exhibits A and B to Exhibit 2 hereof, provided that changes in the Building conditions warrant such changes and will not change the suitability of the Project Real Estate for the Use (all as determined in the sole discretion of the Authorized Officer).

**SECTION 8.** Upon request by the Owner for a final determination of the eligibility of the Project Real Estate for the Class L incentive by the Landmarks Commission pursuant to the Classification Ordinance upon completion of the Substantial Rehabilitation of the Project Real Estate, the commission shall verify that the work performed substantially conforms to the Project approved by the City and that the Project Real Estate is eligible for the Class L incentive (the "Final Determination"). The City hereby determines and directs that the Class L incentive for the Building shall be administered by City staff as follows (this is in addition to any further requirements by the Assessor):

After the Substantial Rehabilitation has been completed, the applicant will notify HED staff in writing, requesting certification. Certification of the project includes the final determination that the project and budget has been met as noted in Exhibit 2, except as otherwise approved by the Authorized Officer pursuant to Section 7 above. Upon request for certification, the applicant will also submit additional information to HED staff, as requested, to document the project and ownership at the time of this request

**SECTION 9.** No permit fee waiver(s) from the City related to the Project Real Estate shall be granted to the Owner or any successor in interest with respect to the Project Real Estate during the rehabilitation of the Project and prior to the expiration of the Class L incentive related to the Project Real Estate.

**SECTION 10.** To the extent that any ordinance, resolution, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this Ordinance, the provisions of this Ordinance shall be controlling. If any section, paragraph, clause or provision shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this Ordinance.

**SECTION 11.** This Ordinance shall be effective from and after its passage and approval.

## **RECOMMENDATION TO THE CITY COUNCIL THAT** A CLASS L REAL ESTATE TAX REDUCTION BE APPROVED FOR

#### Old Dearborn Bank Building 203 N. Wabash

#### To the Mayor and Members of the City Council of the City of Chicago:

Whereas, the Commission on Chicago Landmarks (the "Commission") has reviewed an application for the proposed exterior and interior rehabilitation of the Old Dearborn Bank Building at 203 N. Wabash, proposed for hotel use, (the "Building," and its rehabilitation, the "Project"), pursuant to the Cook County Real Property Assessment Classification Ordinance, as amended (the "County Ordinance"), and its requirements governing the Class L real estate tax incentive (the "Class L"); and

Whereas, the Building was designated as a Chicago Landmark by the City Council of the City of Chicago (the "City Council") on June 4, 2003; now, therefore

#### THE COMMISSION ON CHICAGO LANDMARKS HEREBY:

- 1. Incorporates the above recitals; and
- 2. Finds, based on the Project's budget and proposed scope of work, incorporated herein and attached as Exhibits A and B respectively, that the Project meets or exceeds the Secretary of the Interior's Standards for the Rehabilitation of Historic Buildings; and
- 3. Finds that the Project meets the eligibility criteria for the Class L incentive specified in the County Ordinance; and
- 4. Recommends that the Project be approved for the Class L incentive.

#### EXHIBIT B

#### OLD DEARBORN BANK BUILDING (203 N. Wabash) SCOPE OF THE WORK

**General**. All work affecting the significant historical and architectural features shall be done in accordance with the following:

- The City of Chicago's building permit review procedures and the Landmarks Ordinance, 2-120-580 et seq. of the Municipal Code of Chicago.
- The review and approval of the Commission.
- The U.S. Secretary of the Interior's Standards for the Rehabilitation of Historic Buildings (the "Standards") and the Guidelines for Alterations to Historic Buildings and New Construction, adopted by the Commission on March 7, 1992.
- Historic photographs, architectural drawings, and any other available archival documentation of the building, to be investigated and assembled by the property owner.
- Drawings, dated March 15, 2012, prepared by Booth Hansen and any Commission/PRC conditions of approval.

**Required Approvals.** All work must be submitted to the Commission staff for prior review and approval. The Commission staff may require as part of its review, as appropriate, material samples, paint colors and finishes, shop drawings, specifications, mock-ups, test patches, and control samples.

#### **Required Work.**

#### Exterior:

Work shall include:

- Installation of vegetative 'green' roof over 50% of the net roof area of the building.
- Construction of rooftop addition to include new exterior wall construction at 25<sup>th</sup> floor, terrace assembly at 26<sup>th</sup> floor with 60" tall glass railing system and enlarged window openings for doorways at existing penthouse.
- Architectural accent lighting.
- Removal of fire escapes on north elevation and infill with new windows.

Masonry:

- Rebuilding of parapet walls as necessary. Existing terra cotta and brick to be reinstalled as much as possible.
- Rebuilding of corner brickwork, approx. 75%. New steel angles shall be installed at the corners of the building (where none originally existed) to support the corner masonry.
- Grinding as required and tuckpointing of terra cotta on all elevations.
- Replacement as required of window heads with new extruded terra cotta window heads (65% at center bays and 75-80% at end bays).
- Masonry repair and infill for installation of new windows at locations of removed fire escapes.
- Spot repair or replacement of terra cotta as necessary.
- Façade cleaning of the terra cotta base (floors 1-3) of the building, west and south elevations only.

Storefronts/Windows:

- Replacement of all ground floor storefronts.

- Replacement of 2<sup>nd</sup> and 3<sup>rd</sup> floor window sash with new aluminum window sash within the original ornamental cast-iron frames. Original ornamental cast-iron shall be retained in place, repaired and recoated.
- Replacement of all windows, 4<sup>th</sup> floor to 24<sup>th</sup> floor, with new aluminum windows.

#### Main Entry:

- New entry doors.

#### Interior

Work shall include:

- Conversion of building to a hotel with approximately 250 rooms, public spaces such as meeting rooms and restaurant areas on lower level, 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> floors, a Fitness/Spa on 25<sup>th</sup> floor, and a rooftop restaurant with outdoor terrace on 26<sup>th</sup> floor.
- Renovation of historic lobby. The significant historic and architectural features of the lobby and the grand staircase shall be retained and protected.
- Historic plaster ceiling at 3<sup>rd</sup> floor shall be exposed and restored. A new opening in the floor at 3<sup>rd</sup> floor shall be created where the original opening for the 2<sup>nd</sup> floor bank hall once existed.
- Installation of new wet sprinkler infrastructure and distribution throughout the building.
- New HVAC, plumbing, and electrical systems.

<u>Additional work</u> not required by the Class L, but to be undertaken by the owner, includes: installation of new canopy at the main entry on the west elevation; installation of awnings above storefronts on the south and west elevations; installation of new signage. Any proposed awnings and signage shall be reviewed and approved by the Commission staff. The project is designed to follow Leadership in Energy and Environmental Design (LEED) Certified guidelines.

Work shall occur in accordance with permit drawings for the Project, to be reviewed and approved by the staff of the Commission on Chicago Landmarks. Upon completion of the above scope of work, the project shall exceed ASHRAE 90.1-2004 by at least 14%.






