**ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on map No. 4-I in the area bounded by:

West 21<sup>st</sup> Street; a line 393.5 feet east of and parallel to South Marshall Boulevard (South Douglas Park Boulevard); the public alley next north of and parallel to West 21<sup>st</sup> Street; a line 443.5 feet east of and parallel to South Marshall Boulevard (South Douglas Park Boulevard);

to those of a M1-1 Limited Manufacturing/Business Park District.

SECTION 2. This ordinance takes effect after its passage and approval.
