ORDINANCE

WHEREAS, the City Council of the City of Chicago does not condone the use of marijuana as it is an illegal substance; and

WHEREAS, each year the Chicago Police Department arrests approximately 23,000 individuals for low level possession of marijuana; and

WHEREAS, a disproportionate number of these arrests are of minorities including 78% African-American, 17% Hispanic, and 5% Caucasian; and

WHEREAS, African-Americans account for 78 percent of those arrested, 89 percent of those convicted, and 92 percent of those jailed for low-level marijuana possession in Chicago; and

WHEREAS, the Chicago Police Department spends over 84,000 hours of police time on these types of arrests annually; and

WHEREAS, the 84,000 hours of Police Department resources could be better used on more serious, violent offenses; and

WHEREAS, the cost of jailing these offenders for one day is approximately \$143; and

WHEREAS, the City Council would like to begin a conversation among experts in health and public safety fields to gather data and information on possession of small amounts of marijuana; and

WHEREAS, this ordinance will increase police hours on the streets, reduce costs to the City of Chicago and Cook County, and will increase revenue for the city; and

WHEREAS, other cities in the State of Illinois have enacted similar legislation including Springfield, Carbondale, Champaign, Aurora, and unincorporated Cook County,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Chapter 8-4 of the Municipal Code of the City of Chicago is hereby amended by inserting a new section 8-4-365 as follows:

8-4-365 Possession of cannabis

- (a) All terms and phrases used herein shall have the same meaning as ascribed to them in the Cannabis Control Act (720 ILCS 550/1 et seq.).
- (b) A person commits the offense of possession of cannabis within the City of Chicago by knowingly possessing ten (10) grams or less of any substance containing cannabis unless permitted or authorized to do so pursuant to the Cannabis Control Act (720 ILCS 550/1 et seq.).
- (c) Any person violating subsection (b) shall be subject to a mandatory fine of not more than two hundred dollars (\$200.00) and shall complete ten (10) hours of community service.
- (d) Any person issued a notice of violation for violation of subsection (b) of this Section may request an administrative hearing in accordance with this Code.
