ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all of the DS-5 Downtown Service District symbols and indications as shown on Map No 2-F in the area bound by:

WEST TAYLOR STREET; SOUTH CANAL STREET; VACATED WEST GRENSHAW STREET; AND SOUTH CLINTON STREET.

to those of a DX-5, Downtown Mixed-Use District symbols and a corresponding use district is hereby established.

SECTION 2. That the Chicago Zoning Ordinance be amended by changing all the DX-5 symbols and indications in the area described above to those of Business-Residential Planned Development No., and a corresponding use district is hereby established.

SECTION 3. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about March 12, 2012, the undersigned will file an application for a change in zoning from DS-5 to a DX-5 and then to a Residential-Business Planned Development on behalf of Canal TC, LLC for the property located at 1001-1121 South Clinton; 501-513 W. Taylor; 1001-1121 South Canal.

The applicant intends to use the subject property to develop an 8 story mixed use project, with 443 residential units with 885 parking spaces, and two stories of retail space – a total of approximately 192,000 square feet of commercial space – for multi-tenant use. The existing commercial/industrial building is currently vacant.


