ORDINANCE UNIVERSITY OF CHICAGO Acct. No. 43697 - 104 Permit No. 1100404

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to UNIVERSITY OF CHICAGO, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Utility Trench under the public right-of-way adjacent to its premises known as 1100 E. 57th St..

Said Utility Trench at E. 57th Street To 5735 South Ellis Ave measure(s):

One (1) chilled water supply pile at seventy-four (74) in length and twenty (20) inches in diameter.

One (1) chilled water return pipe at seventy-four (74) feet in length and twenty (20) inches in diameter.

Two (2) NSIT pipes at seventy-four (74) feet in length and four (4) inches in diameter.

Said utility trench under and along East 57<sup>th</sup> Street shall measure fifty-two (52) feet in length and ten (10) feet in width and continue under and along East 57<sup>th</sup> Street twenty-two (22) feet in length and fourteen (14) feet in width. Utility trench shall be ten (10) feet below grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1100404 herein granted the sum of one thousand six hundred (\$1,600.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
