ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code, the Chicago Zoning Ordinance,

is hereby amended by changing all the RS-3 Residential Single-Unit (Detached House)

District symbols and indications as shown on Map No. 11-J in the area bounded by

West Sunnyside Avenue; the alley next east of and parallel to North Spaulding Avenue; a line 38.6 feet south of and parallel to West Sunnyside Avenue; and North Spaulding Avenue,

to those of an RM-4.5 Residential Multi-Unit District and a corresponding uses district.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due

publication.




