## SUBSTITUTE ORDINANCE

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The City Council finds that the areas described in this ordinance are adversely affected by the over-concentration of businesses licensed to sell alcoholic liquor within and near the areas.

SECTION 2. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as a new subsection 4-60-022 (42.5) through 4-60-022 (42.28), as follows:

#### 4-60-022 Restrictions On Additional Licenses.

Subject to the provisions of subsection 4-60-021 (c), no additional license shall be issued for the sale of alcoholic liquor, for consumption on the premises within the following areas:

- 5) On the south side of Hubbard Street, from State Street to Clark Street.
- 6) On the south side of Hubbard Street, from Clark Street to Wells Street.

- 7) On the north side of Hubbard Street, from State Street to Clark Street.
- 8) On the north side of Hubbard Street, from Clark Street to Wells Street.
- 9) On the south side of Kinzie Street, from State Street to Clark Street.
- 10) On the south side of Kinzie Street, from Clark Street to Wells Street.
- 11) On the north side of Kinzie Street, from State Street to Clark Street.
- 12) On the north side of Kinzie Street, from Clark Street to Wells Street.
- 13) On the east side of Franklin Street, from Ontario Street to Huron Street.
- 14) On the west side of Franklin Street, from Ontario Street to Huron Street.

15) On the north side of Illinois Street, from State Street to Clark Street.

- 16) <u>On the north side of Illinois Street, from Clark Street to Wells Street.</u>
- 17) On the south side of Illinois Street, from State Street to Clark Street.
- 18) On the south side of Illinois Street, from Clark Street to Wells Street.

19) <u>On the east side of Dearborn Street, from the north bank of the Chicago River to Illinois</u> <u>Street.</u>

20) On the west side of Dearborn Street, from the north bank of the Chicago River to Illinois Street.

- 21) On the east side of Clark Street, from the north bank of the Chicago River to Illinois Street.
- 22) On the west side of Clark Street, from the north bank of the Chicago River to Illinois Street.
- 23) On the east side of LaSalle Street, from the north bank of the Chicago River to Illinois Street.
- 24) On the west side of LaSalle Street, from the north bank of the Chicago River to Illinois Street.
- 25) On the east side of Wells Street, from the north bank of the Chicago River to Illinois Street.
- 26) On the west side of Wells Street, from the north bank of the Chicago River to Illinois Street.
- 27) On the east side of State Street, from the north bank of the Chicago River to Illinois Street.
- 28) On the west side of State Street, from the north bank of the Chicago River to Illinois Street.
