### ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Chapter 4-244-140 of the Municipal Code of Chicago is hereby amended by adding the language underscored as follows:

#### 4-244-140 Prohibited districts.

(a) No one having a peddler's license shall peddle any merchandise or any other article or thing whatsoever, at any time, within districts which have been or shall be hereafter designated by the city council. A description of such districts shall be kept in the office of the city clerk.

(22) Peddling is prohibited at any time within the 37th Ward boundaries:

Beginning at the intersection of West Thomas Street and North Pulaski Road; thence south on North Pulaski Road to West Chicago Avenue; thence west on West Chicago Avenue to North Lamon Avenue; thence south on North Lamon Avenue to West Ferdinand Street; thence west on West Ferdinand Street to North Lavergne Avenue; thence north on North Lavergne Avenue to West Chicago Avenue; thence west on West Chicago Avenue to North Lockwood Avenue; thence south on North Lockwood Avenue to West Ferdinand Street; thence west on West Ferdinand Street to North Pine Avenue; thence north on North Pine Avenue to West Race Avenue; thence west on West Race Avenue to North Central Avenue; thence north on North Central Avenue to the southernmost centerline of the Soo Line Railroad; thence east on the southernmost centerline of the Soo Line Railroad to North Long Avenue extended; thence north on North Long Avenue extended and North Long Avenue to West Grand Avenue; thence northwest on West Grand Avenue to North Central Avenue; thence north on North Central Avenue to West Palmer Street; thence west on West Palmer Street to North Mango Avenue; thence south on North Mango Avenue to West Grand Avenue; thence northwest on West

Grand Avenue to North McVicker Avenue; thence north on North McVicker Avenue to West Fullerton Avenue; thence east on West Fullerton Avenue to North Marmora Avenue; thence south on North Marmora Avenue to West Belden Avenue; thence east on West Belden Avenue to North Monitor Avenue; thence north on North Monitor Avenue to West Altgeld Street; thence east on West Altgeld Street to North Menard Avenue; thence south on North Menard Avenue to West Fullerton Avenue; thence east on West Fullerton Avenue to North Laramie Avenue; thence south on North Laramie Avenue to West Palmer Street; thence east on West Palmer Street to North Leclaire Avenue; thence south on North Leclaire Avenue to West Grand Avenue; thence southeast on West Grand Avenue to West Hirsch Street; thence west on West Hirsch Street to North Karlov Avenue; thence south on North Karlov Avenue to West Thomas Street; thence east on West Thomas Street to the place of beginning.
