#### **ORDINANCE**

UNITED NEIGHBORHOOD ORGANIZATION OF CHICAGO Acct. No.

351473-2 Permit No. 1092701

#### Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to UNITED NEIGHBORHOOD ORGANIZATION OF CHICAGO, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use sixteen (16) Light Fixture(s) projecting over the public right-of-way adjacent to its premises known as 2744 W. Pershing Rd..

### Said Light Fixture(s) at W. PERSHING ROAD measure(s):

Eight (8) at point zero eight (.08) feet in length, point one seven (.17) feet in width and ten (10) feet above grade level. Eight (8) at point zero eight (.08) feet in length, point one seven (.17) feet in width and twenty (20) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1092701 herein granted the sum of seventy-five (\$75.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
