#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1. Pursuant to Title 9, Chapter 64, Section 090, of the Municipal Code of Chicago, portions of the below named streets are hereby designated as residential permit parking zones, for the following locations:**

#### WARD RESIDENTIAL PERMIT PARKING:

25 2137 to 2159 W. 22nd Place; 2124 to 2158 W. 22nd Place: Residential Permit Parking Zone 1066, all times [02013-1814]

2900 block of W. Adams, Amend Residential Permit Parking Zone 1700, All times, by striking: north side and inserting: both sides [02013-1912]

2600 block of W. 15th Place (both sides): Residential Permit Parking Zone 1732. All Times [02013-209]

4000 block of W. Dickens Avenue, from N. Karlov Avenue to N. Keystone Avenue (both sides), Residential Permit Parking Zone 1731, Sunday through Saturday, 6:00 pm to 6:00 am [02012-585]

4814 - 4856 and 4815 - 4857 W. Wolfram Avenue: Residential Permit Parking Zone 1729, all times [Or2013-184]
