Comptroller upon receipt by the Comptroller of a voucher signed by the appropriate alderman or by his or her designee. Aldermen may combine all or portions of their respective expense allowances to retain one or more contractors to provide technical and fiscal analysis and advice concerning the annual city budget, proposed sale or lease of city assets, or other financial matters, subject to the same warrant procedure; provided, however, (i) that each alderman participating in such a contract shall contribute equally to the cost of the contract, and (ii) that all costs of such contract shall be fixed in advance, and (iii) that the contract shall first be approved by the Corporation Counsel as to form and legality and by the City Comptroller as to availability of funds. 4,983,924 9008
