ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code, the Chicago Zoning Ordinance, be amended by changing all the B3-1 Community Shopping District symbols and indications as shown on Map No. 11 - J in the area bounded by

the alley next south of and parallel to West Belle Plaine Avenue; North Kedzie Avenue; a line 264.45 feet south of and parallel to West Belle Plaine Avenue; and the alley next west of and parallel to North Kedzie Avenue, to those of a C2-2 Motor Vehicle-Related Commercial District is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
