#### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 14-H in the area bounded by

A line 291 feet north of the north boundary line of West 57<sup>th</sup> Street (as measured along the west boundary line of south Oakley Avenue); North Oakley Avenue; a line 216 feet north of the north boundary line of West 57<sup>th</sup> Street (as measured along the west boundary line of South Oakley Avenue); the public alley next west of South Oakley Avenue,

to those of a B3-2 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.
