A line 166.30 feet north of and parallel to East Lake Street; North Michigan Avenue; East Lake Street; North Garland Court

to the designation of Residential Business Planned Development No. ____ which is hereby established in the area above described, subject to such use and bulk regulations as are set forth in the Plan of Development herewith attached and made a part thereof and to no others.

SECTION 2: This Ordinance shall be in force and effect from after its passage and due publication.

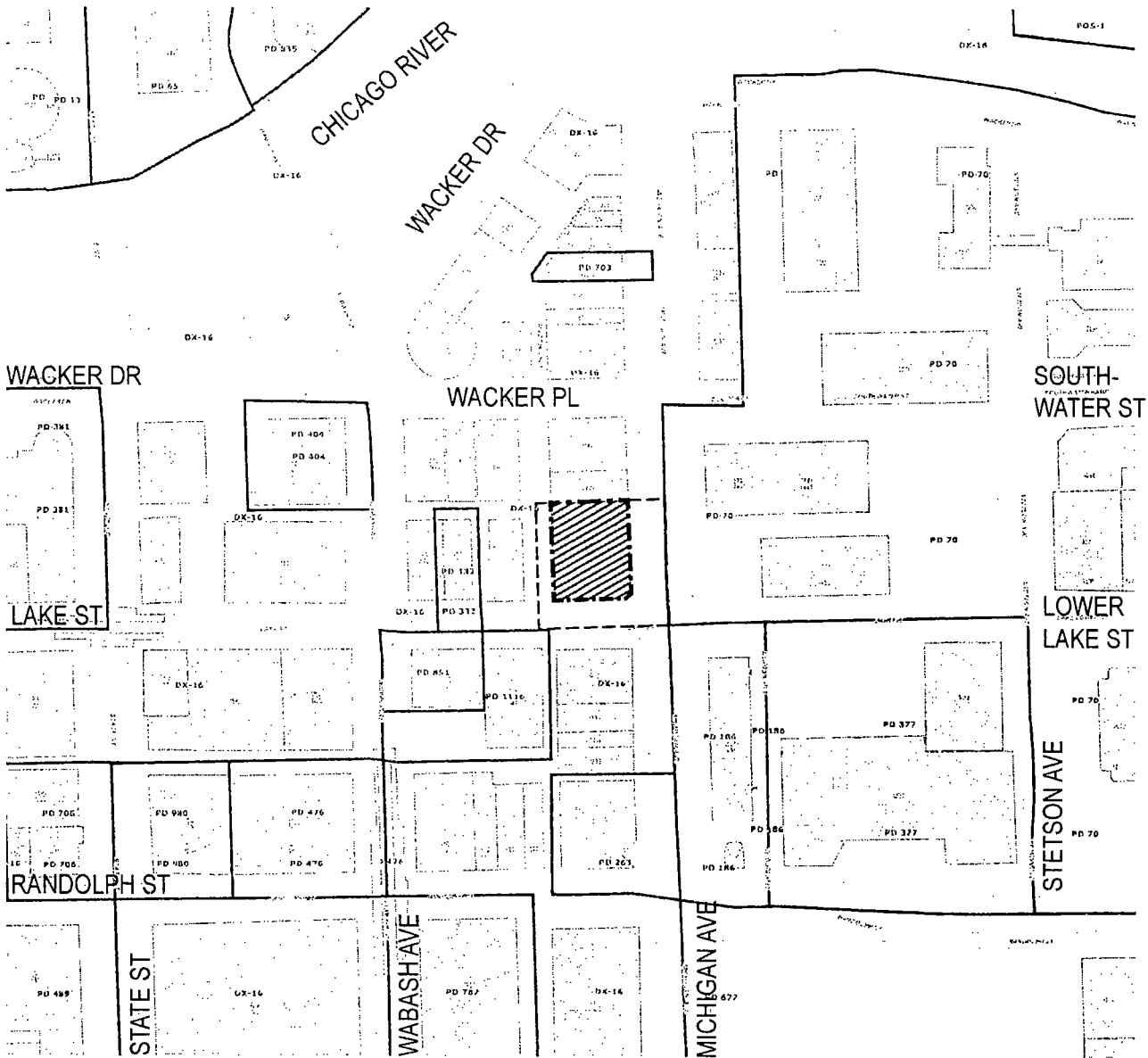

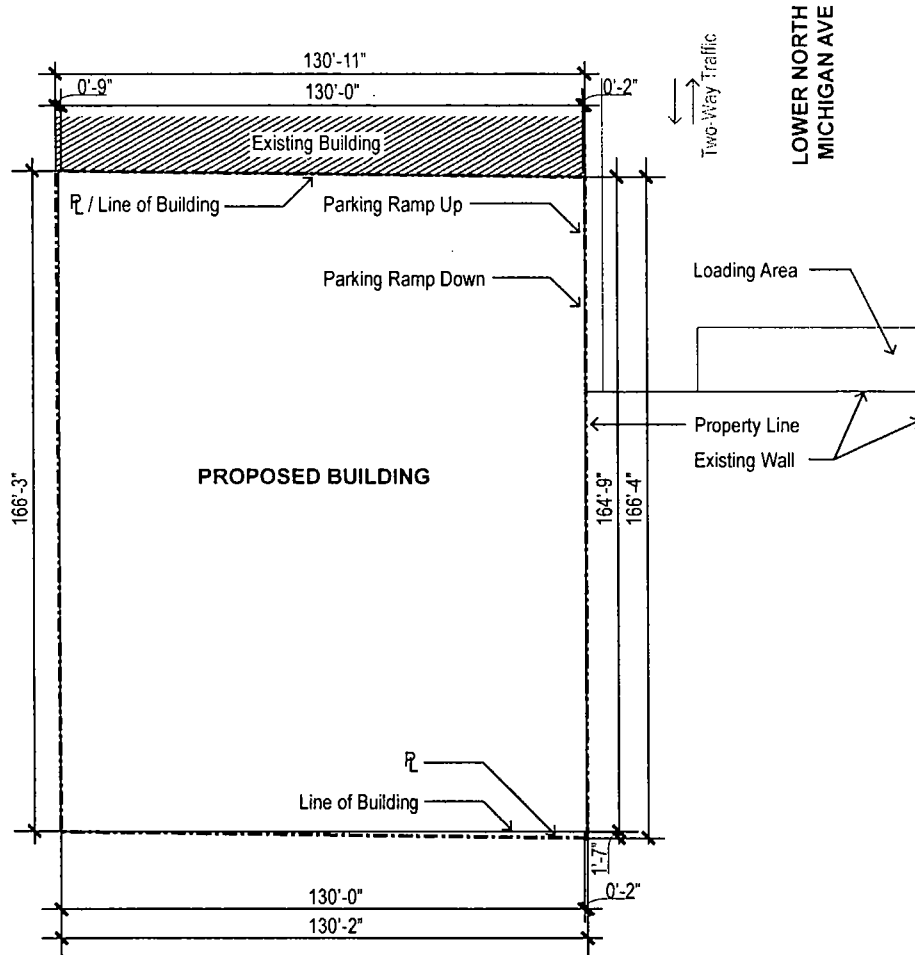
SITE PLAN

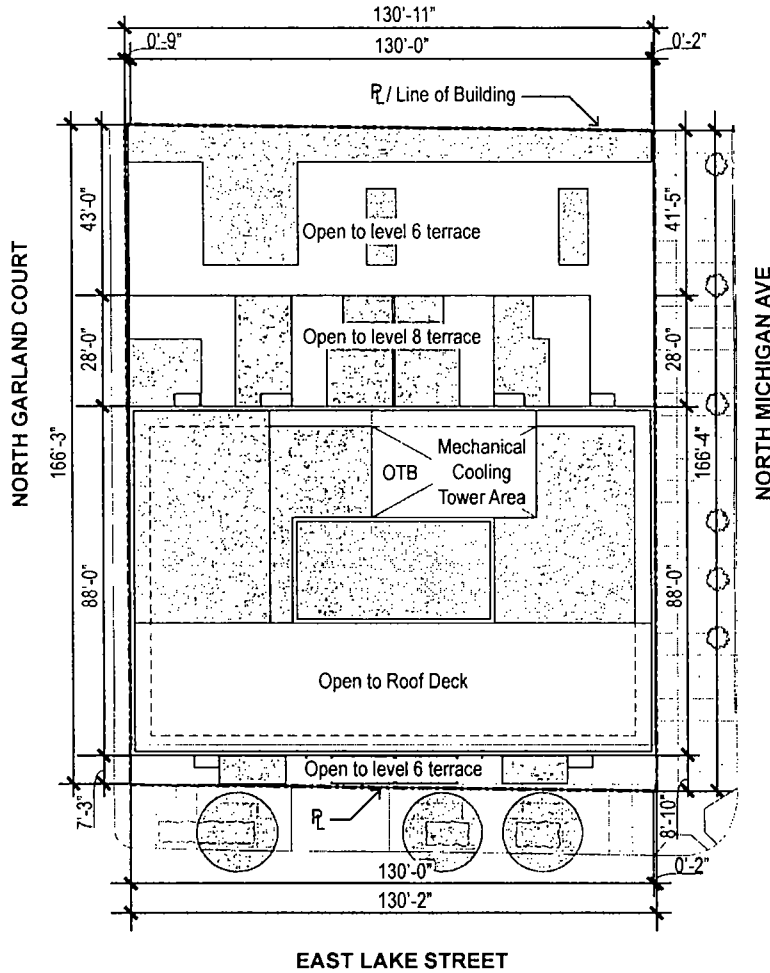
LOWER LEVEL 1 PLAN

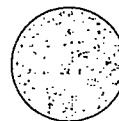
LANDSCAPE & GREEN ROOF PLAN

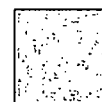

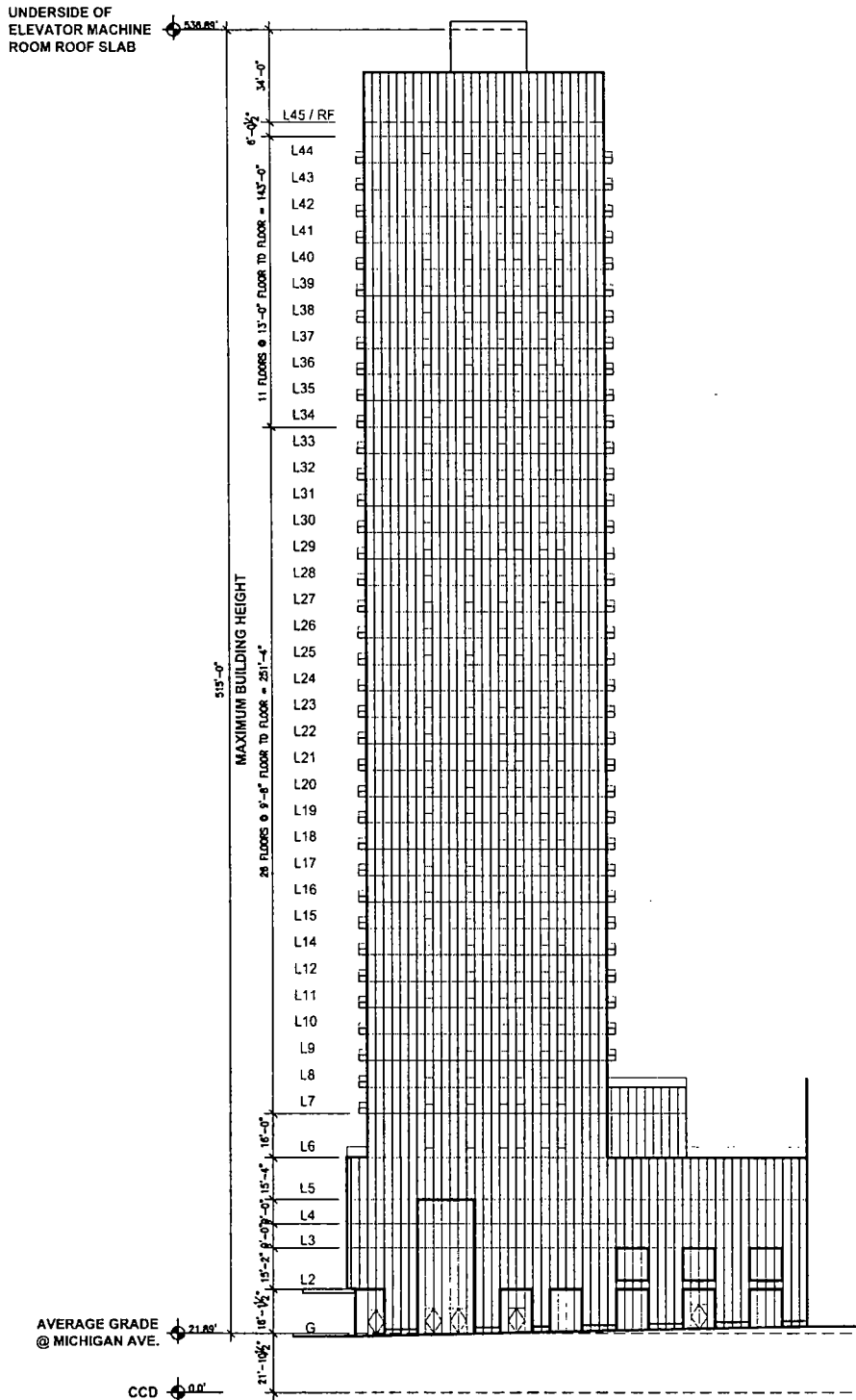

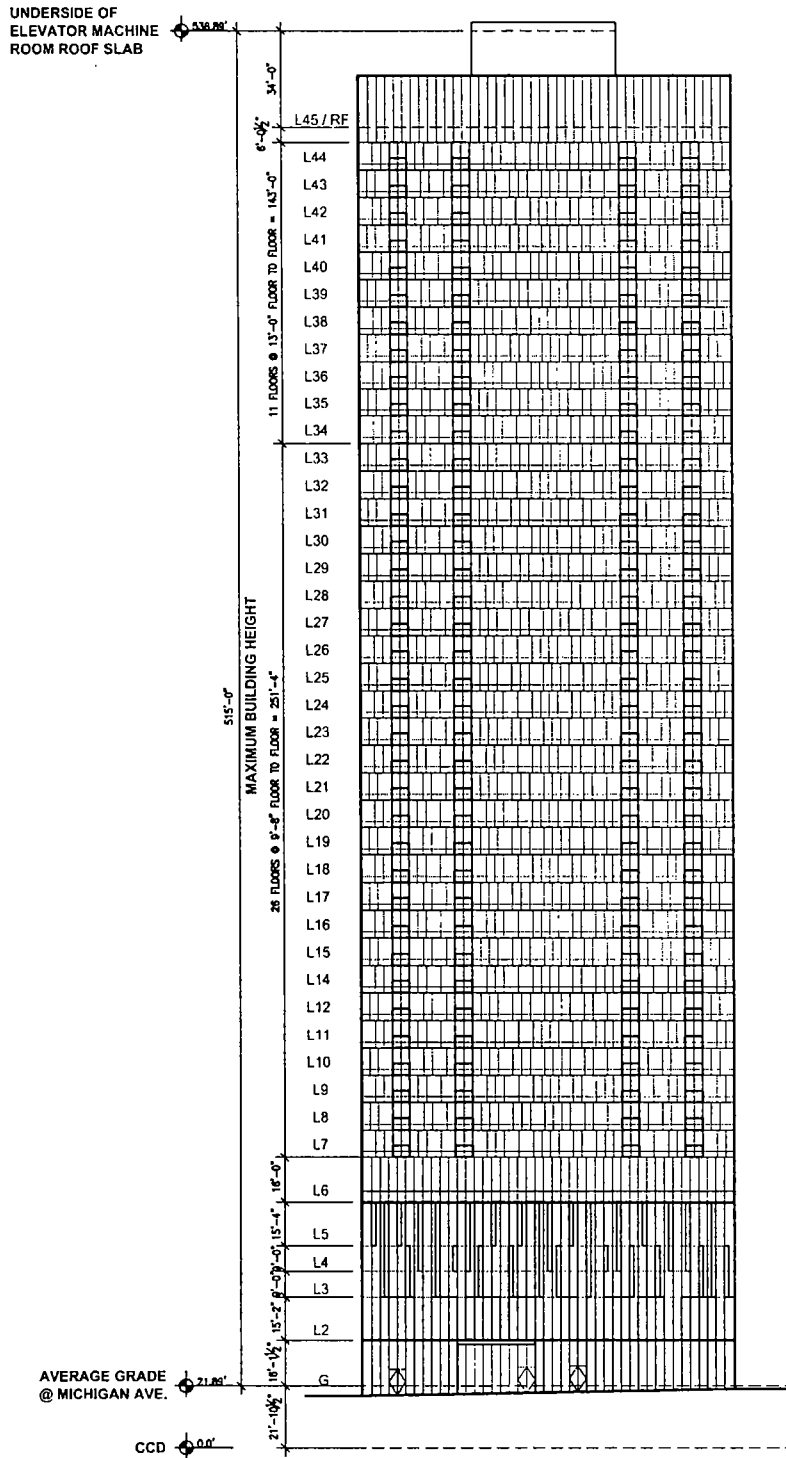


EAST BUILDING ELEVATION

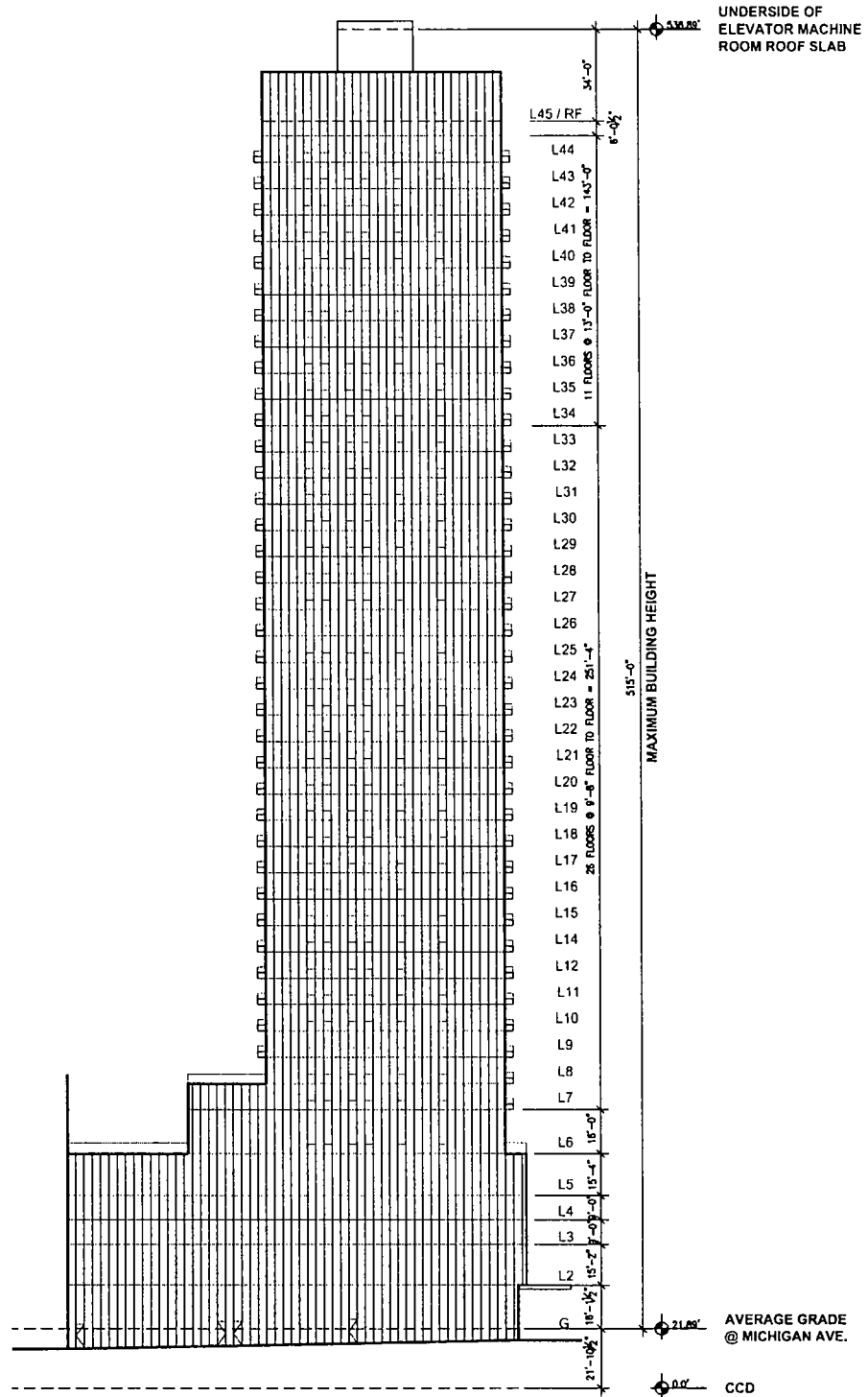


SOUTH BUILDING ELEVATION

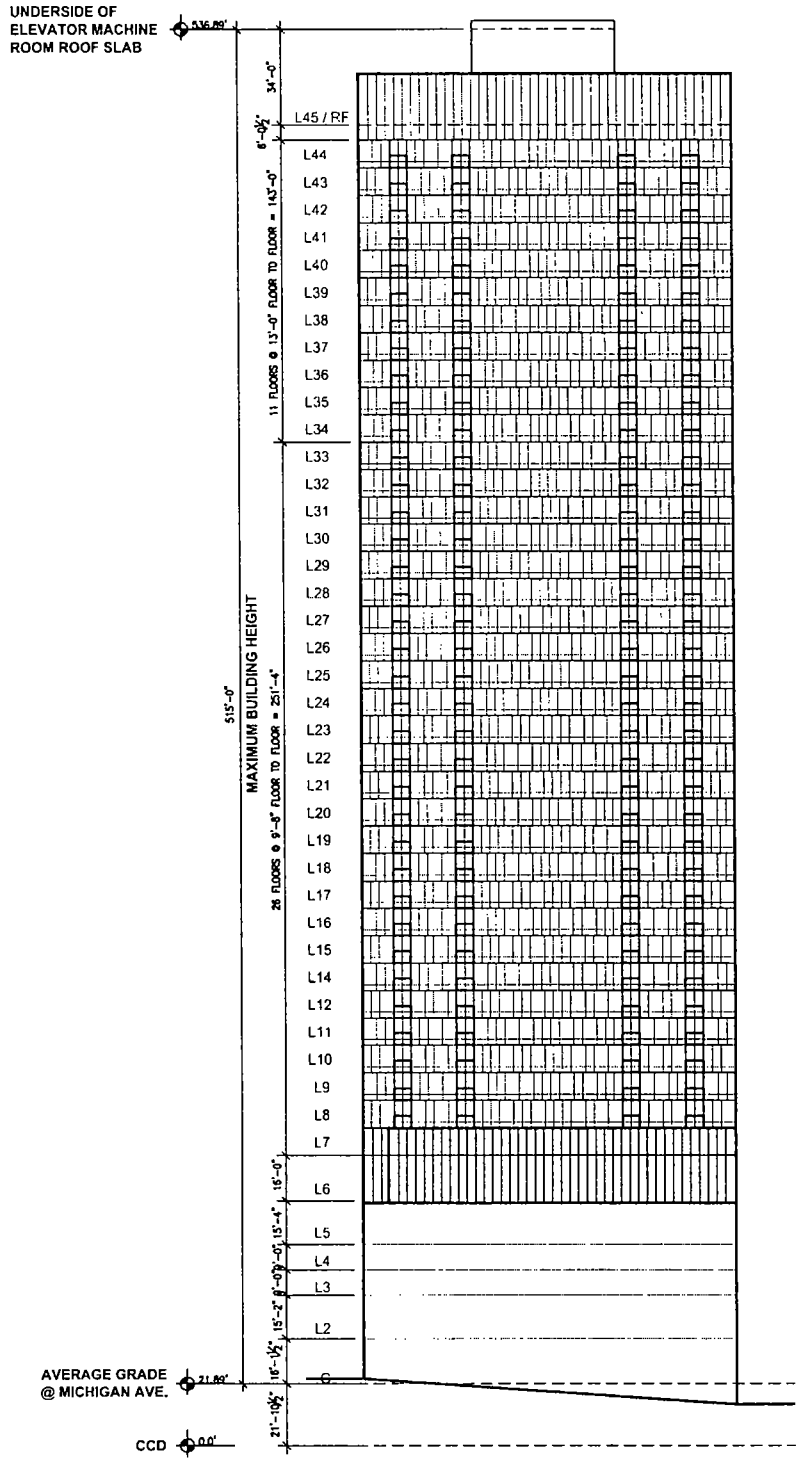

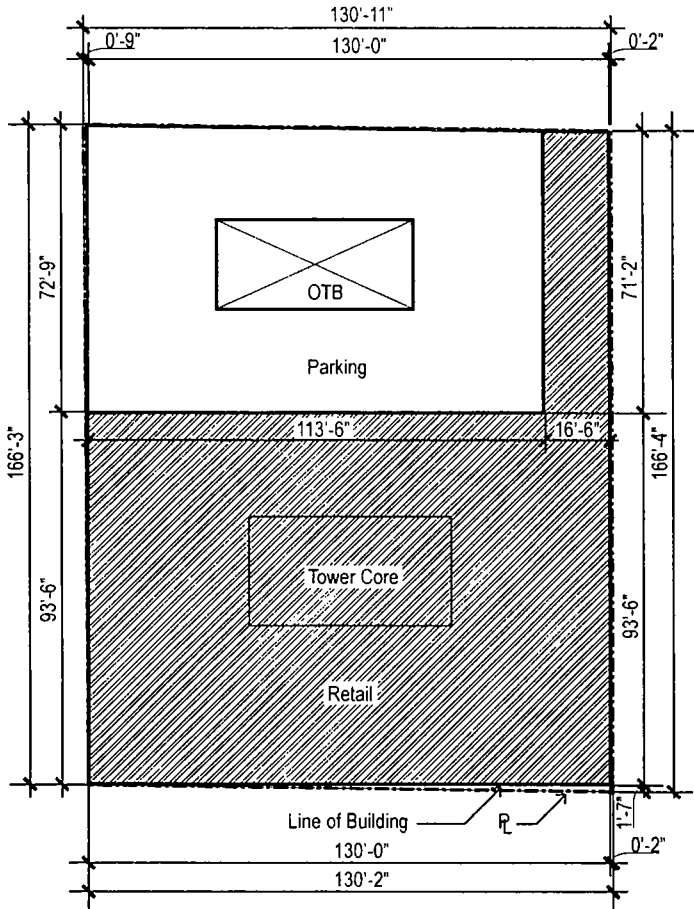


NORTH BUILDING ELEVATION

LEVEL 2 PLAN DIAGRAM

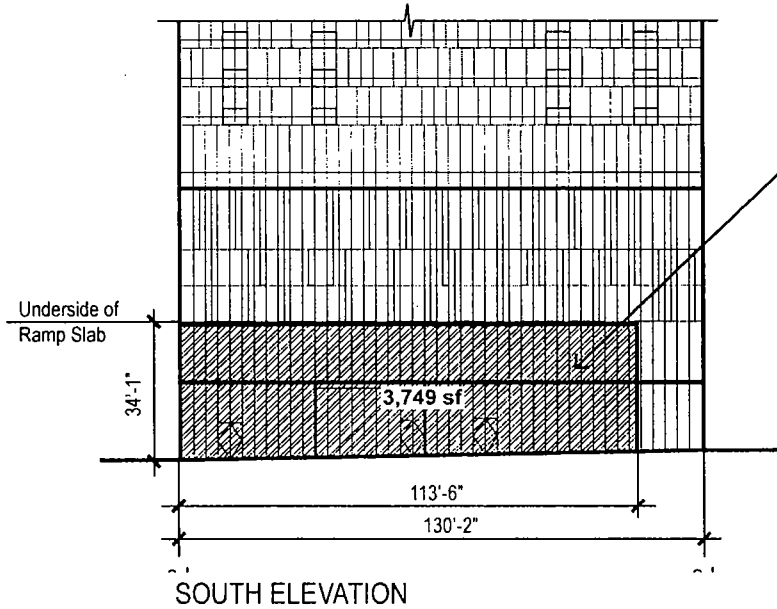
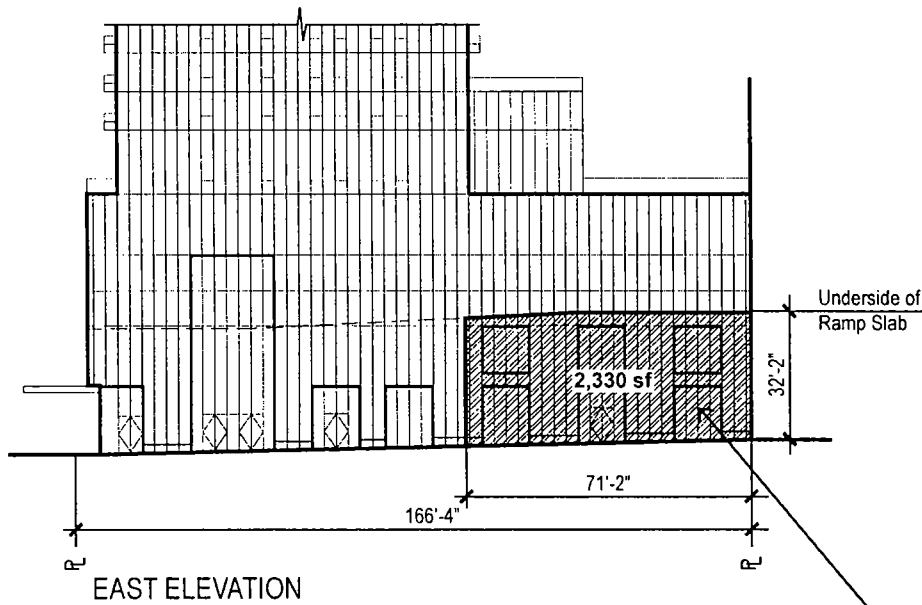

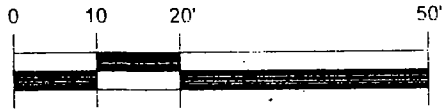
