ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No. 16-L in an area bound by

A line 55.25 feet south of and parallel to West 63rd Place; the public alley next east of and parallel to South Central Avenue; a line 107.25 feet south of and parallel to West 63rd Place; And South Central Avenue

to those of a C1-2 Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and due publication.
