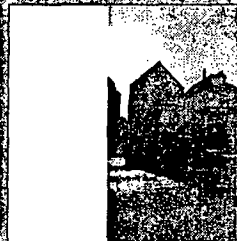
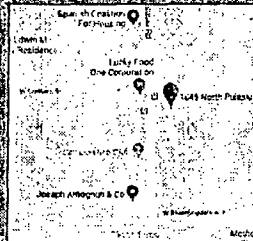
to those of a RT-4, Residential Two-Flat, Townhouse and Multi-Unit District.
