A perpendicular public alley to South Bishop Street and is next south of and parallel to West 18<sup>th</sup> Street; the public alley running southwesterly of West 18<sup>th</sup> Street and that is northwest of and parallel to South Blue Island Avenue; South Bishop Street

to those of a C1-2 Neighborhood Commercial District, and a corresponding uses district is hereby established in the area above described.
