**SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, that the Commissioner of Transportation is hereby authorized and directed to erect and amend Traffic Warning Signs and Signals, for the following locations are hereby designated:**

40	W. Farragut Avenue; W. Farragut Avenue and N. Rockwell Street; All Way Stop Sign, stopping all approaches -- (14-00433357) [Or2013-526]

**SECTION 2. This ordinance shall take effect and be in force here in after its passage and publication.**


