*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to SOUTH EAST CHICAGO COMMISSION upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Trash container(s) on the public right-of-way adjacent to its premises known as 380 E 51ST ST.

Said Trash container(s) at E. 51st Street measure(s):  
One (1) at one (1) feet in length and Zero (0) feet in width for a total of one (1) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

A 25% penalty will be added for payments received after due date.

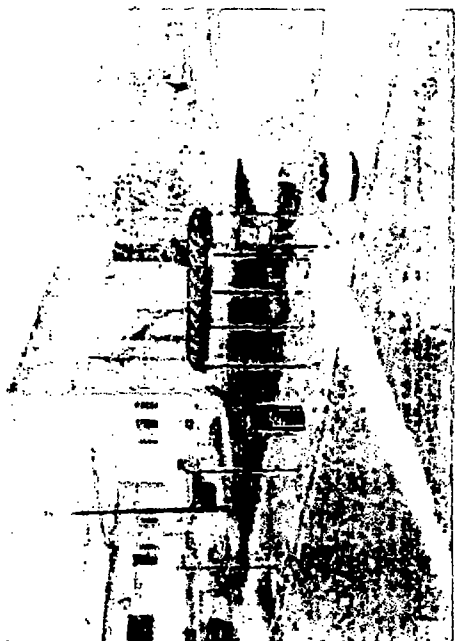
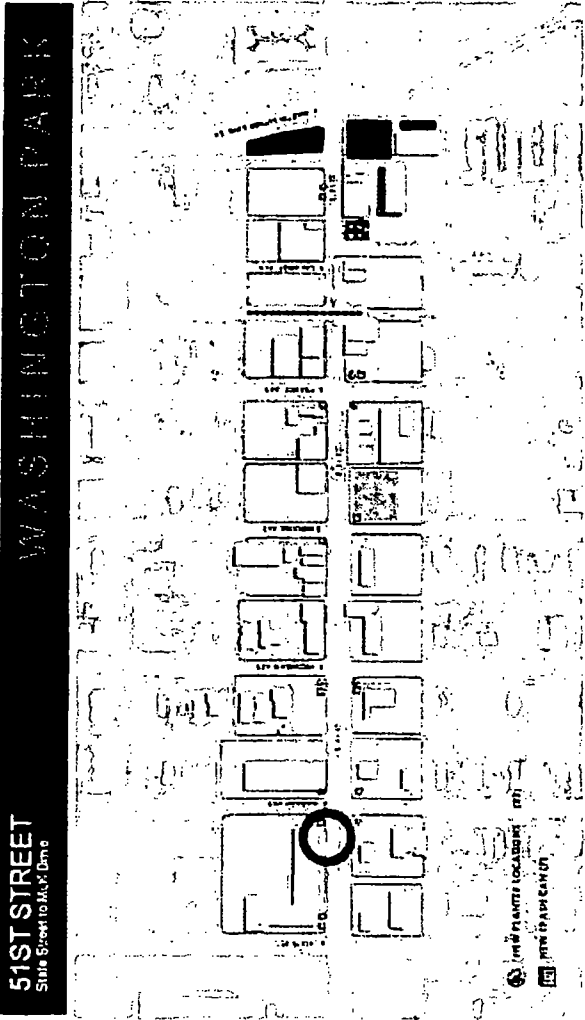
