The north branch of the Chicago River, West Fullerton Avenue; North Elston Avenue; and North Damen Avenue,

to those of a C3-3 Commercial, Manufacturing, and Employment District.

SECTION 2 This Ordinance shall be in force and effect from and after its passage and due publication.



In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107 of the Municipal Code of the City of Chicago, please be informed that on or about November 16, 2022, the undersigned, on behalf of Vienna Beef, Ltd. (the "Applicant"), intends to file an application to rezone the property generally located at 2501 N. Damen / 1880 W. Fullerton / 2417 N. Elston, Chicago, Illinois (the "Property") from Waterway Planned Development 1471 to the C3-3 Commercial, Manufacturing, and Employment District. A map of the Property is printed on the reverse side of this letter.

The Property is currently the site of commercial and vacant land. 
