to those of a C3-3 Commercial, Manufacturing, and Employment District.

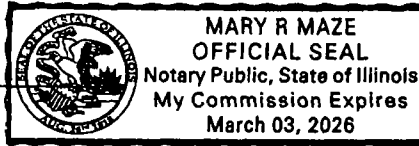

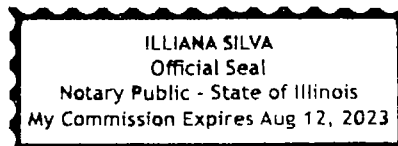

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107 of the Municipal Code of the City of Chicago, please be informed that on or about November 16, 2022, the undersigned, on behalf of Vienna Beef, Ltd. (the "Applicant"), intends to file an application to rezone the property generally located at 2501 N. Damen / 1880 W. Fullerton / 2417 N. Elston, Chicago, Illinois (the "Property") from Waterway Planned Development 1471 to the C3-3 Commercial, Manufacturing, and Employment District. A map of the Property is printed on the reverse side of this letter.

The Property is currently the site of commercial and vacant land. The Applicant is requesting a rezoning of the subject property from Waterway Planned Development 1471 (the "PD") to the C3-3 Commercial, Manufacturing, and Employment District, as directed by Statement 17 of the PD, because the previously-contemplated development of the Property by a third party with a virtual golf and entertainment facility pursuant to the PD will not proceed.
