to those of a B2-3 Neighborhood Mixed-Use District which is hereby established in the area described above.



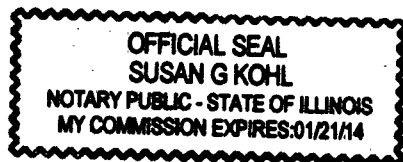

Please take notice that under the Chicago Zoning Ordinance an application (the "Application") to amend the zoning from a C1-2 Neighborhood Commercial District to a B2-3 Neighborhood Mixed-Use District for the area which is bounded by:


a line 49.00 feet north of West 18th Street; the alley next east of South Throop Street; West 18th Street; and South Throop Street

(hereafter the "Property") will be filed on or about July 20, 2011 with the Department of Housing and Economic Development, City of Chicago by 1657 S. Throop, LLC, 1241 W. Cottage Place, Chicago, IL 60607 (hereinafter the "Applicant"). The addresses that correspond to the Property are 1657 – 59 S. Throop St. and 1248 – 58 West 18th Street. The Applicant is the owner of the Property.

The Property is currently improved with three buildings with a total of 13 dwelling units as follows: 1) 1657 S. Throop which is a three story building with six units and no parking; 2) 1659 S. 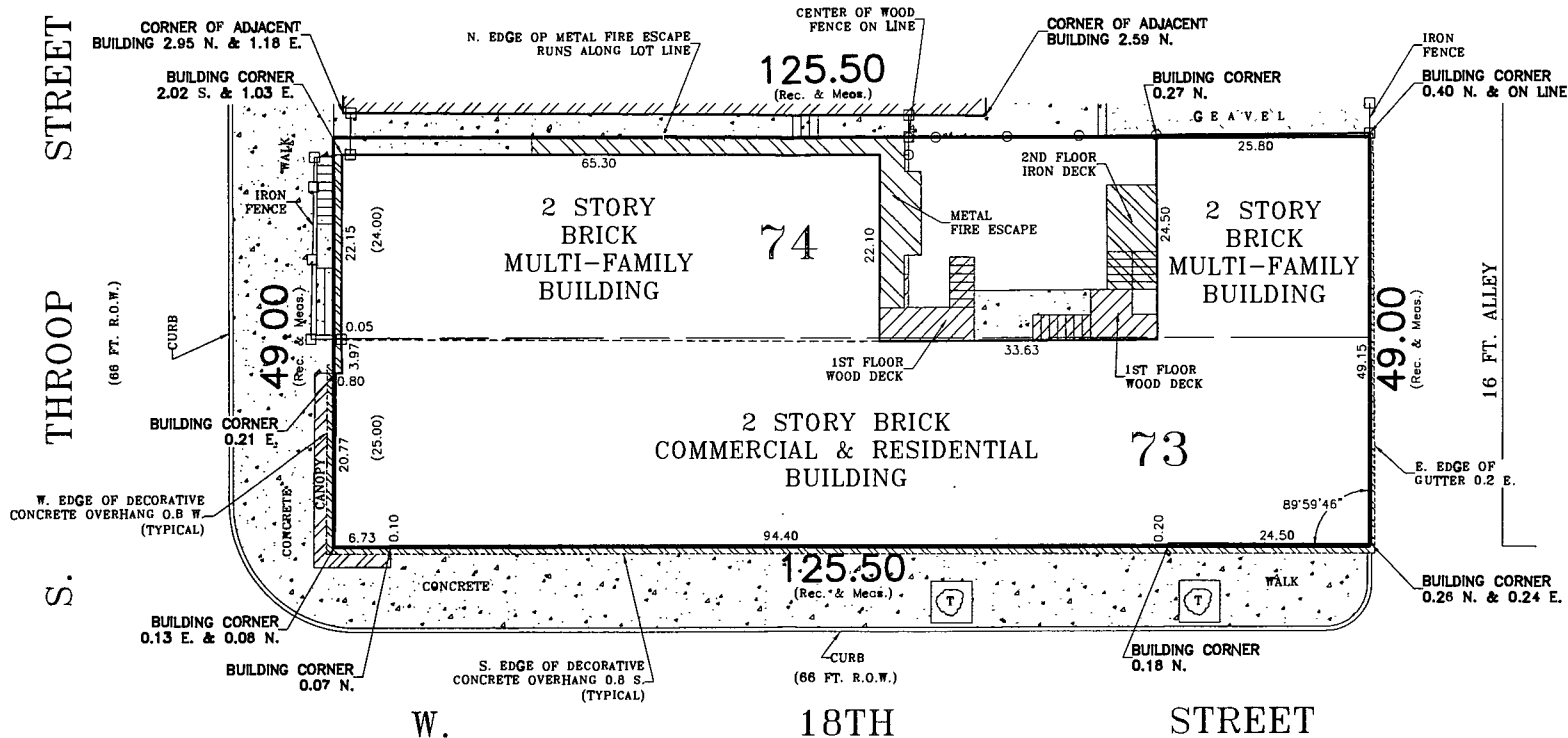
