*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to Shadowbox LLC, upon the terms and subject to the conditions of this ordinance to maintain and use one (1) sign(s) projecting over the public right-of-way attached to its premises known as 667 N. Wells St..

Said sign structure(s) measures as follows; along N. Wells Street:

One (1) at fifteen point eight three (15.83) feet in length, one point two five (1.25) feet in height and fifteen (15) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1145759 herein granted the sum of one hundred (\$100.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.

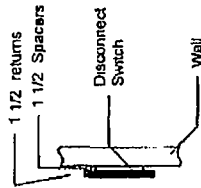
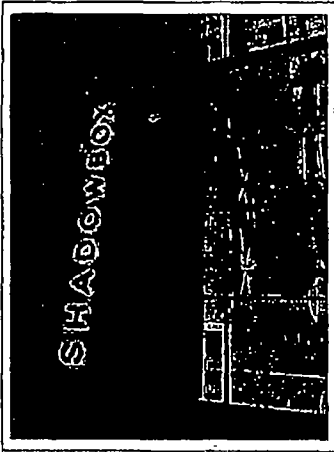

## HALO ILLUMINATED LETTERS

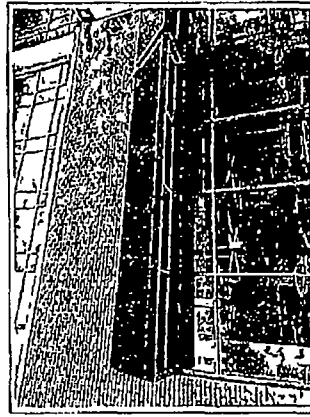
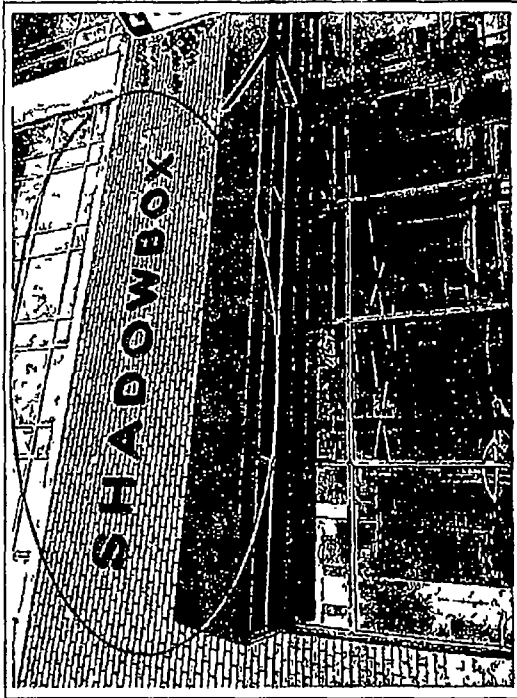
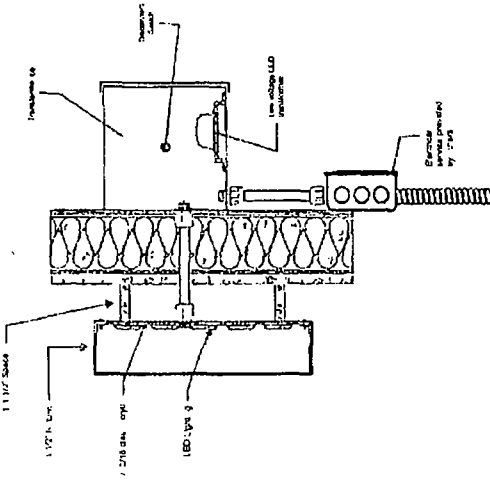
FABRICATE AND INSTALL LETTERS OF ALUMINUM AND CLEAR LEXAN LETTER FACES AND RETURNS TO BE ALUMINUM. LETTER BACKS TO BE CLEAR LEXAN. ALL EXPOSED METAL TO BE COATED WITH ACRYLIC POLYURETHANE. INTERNAL ILLUMINATION TO BE WHITE LEDS.

## INSTALLATION INSTRUCTIONS

CENTER NEW SIGN TOP/BOTTOM  
LEFT/RIGHT ON WALL SHOWN.  
CONNECT TO ELECTRICAL SERVICE  
TO BE PROVIDED BY OTHERS PRIOR TO INSTALL

- The letters are individually mounted and lit with no raceways
- Penetration will be at a minimal disruption
- Scrubbing of the brick layout and pattern so every stud can penetrate through mortar instead of any brick
- Tapcons through the mortar
- Each letter is individually lit powered and daisy chained on the back side of the wall
