THE CENTURY

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to THE CENTURY, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Marquee(s) projecting over the public right-of-way adjacent to its premises known as 2828 N. Clark St..

Said Marquee(s) at N CLARK ST measure(s):

One (1) at sixty-six (66) feet in length, and five point five eight (5.58) feet in width for a total of three hundred sixty-eight point two eight (368.28) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.


The grantee shall pay to the City of Chicago as compensation for the privilege #1117597 herein granted the sum of ninety-one (\$91.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.

1 - ID Letterset

30"H face lit channel letters with base mounted raceway and 2" Painted baffle

2 - Canopy Refresh

Remove existing decorative bars, refresh cabinet skin with new paneling and on-site angle framing to square off. Attach new 4"H x 1" painted channels attached to new face. Refresh lamps, ballasts, and configuration as needed.

3 - Reader Boards

Retro body with 1-1/2" hinge faces with translucent white polycarb panels and "zip change" rails and acrylic letter panels with screen printed letters. Paint black zip-tracks between theaters for separation. Theater numbers - Routed and backed up with white acrylic, illuminated from canopy.

3 - Cont.

Outside left/right panels for other tenant advertising space. Retro-fitted with slide retainers and faux center dividing bars to accept decorated polycarb panels.

4 - Secondary Sign Band

Remove existing sign band graphics. Facade repaired by others.

5 - Column Mounted Sign Box

3-1/4" Slim single face sign cabinet with 1-1/2" hinged face with acrylic panel with graphics TBD (Mall directory or advertising space). Illuminated with White LED lighting.

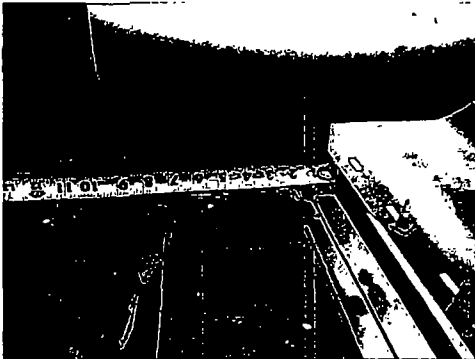
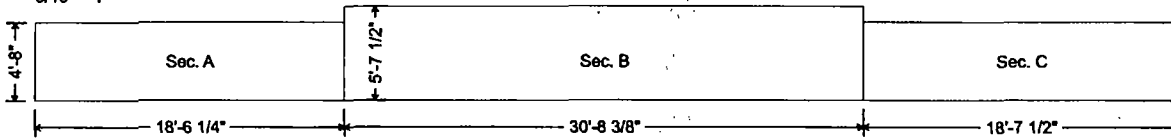

Existing structure - 7" Deep fabricated aluminum cabinets internally illuminated with fluorescent lamps with routed and backed up numerals, built-in retainers for plex faces w/zip-track letters

Remove existing fabricated silver channels wrapping face and return illuminated from inside with lamps

Field cut existing sections to leave +/- 2" borders for new panel attachment
Refresh lamps, ballasts, and configuration as needed
