## ORDINANCE

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** Chapter 2-32 of the Municipal Code of Chicago is hereby amended by inserting new section 2-32-081, as follows:

**2-32-081 Consolidated billing.**


(a) For any business licensed under Title 4 of this Code, the comptroller shall send one annual consolidated bill for any of the following fees due and owing by such business during that calendar year in which the bill was sent:

- (1) a license under Title 4;
- (2) a permit for any and all public way uses;
- (3) a permit for a sign or billboard;
- (4) a permit for a sidewalk café;
- (5) annual building, zoning or fire inspections; and
- (6) a loading zone sign.

(b) The heads of all applicable city departments shall assist and cooperate with the comptroller in the issuance of each annual consolidated bill required by this section.

(c) Nothing in this section shall be construed to apply to any fee charged for a re-inspection, emergency re-inspection, or inspection conducted by the Department of Buildings in response to a complaint.

**SECTION 2.** This ordinance shall take effect upon its passage and publication.
