AN ORDINANCE Declaring Intent to Issue City of Chicago Chicago O'Hare International Airport Special Facility Revenue Bonds in an Aggregate Principal Amount Not to Exceed \$200,000,000 for the Benefit of Transportation Infrastructure Properties, LLC and/or Aero O'Hare, LLC or Affiliates Thereof, Authorizing the Ground Lease for the Willow Creek Facility to be Divided into Two Separate but Substantially Identical Ground Leases so that a New DHL Facility May be Financed Separately from the Existing Facilities, and Approving the Execution and Delivery of the Recognition, Non-Disturbance and Attornment Agreement with the Tenant of the DHL Facility.

WHEREAS, the City of Chicago (the "City"), is a duly constituted and existing municipality within the meaning of Section 1 of Article VII of the 1970 Constitution of the State of Illinois (the "Constitution") having a population in excess of 25,000 and is a home rule unit of local government under Section 6(a) of Article VII of the Constitution; and

WHEREAS, the City owns and operates an airport known as Chicago O'Hare International Airport (the "Airport"); and

WHEREAS, the City leases certain property at the Airport to affiliates of Transportation Infrastructure Properties, LLC, a Delaware limited liability company, including Aero O'Hare, LLC, a Delaware limited liability company, and Aero Chicago, LLC (collectively, and together with one or more affiliates of either or both such entities, the "Borrower") pursuant to (i) (for the NE Cargo facility referenced below) the Aero Chicago LLC Cargo Facility Phase I Lease, dated August 8, 2012 between City of Chicago and Aero Chicago, LLC, Aero Chicago, LLC Phase I Cargo Facility, Chicago O'Hare International Airport and (ii) (for the DHL Global Forwarding Center referenced below) the Lease At Chicago O'Hare International Airport between City of Chicago and O'Hare Tech Center II, LLC, dated February 5, 2002 (Location: Willow Creek Parcel (bounded on the north by Touhy Avenue and to the east by Lee Street) O'Hare International Airport, Chicago, Illinois, as amended June 14, 2002 and subsequently assigned to a Borrower affiliate (the "Willow Creek Ground Lease"), which facilities are to be managed by AeroTerm, US, Inc.; and

WHEREAS, the Borrower has requested that the City issue its special facility airport revenue bonds, notes or other indebtedness in an amount not to exceed Two Hundred Million Dollars (\$200,000,000) (the "Bonds") in one or more series (and which series may be for the benefit of separate Borrower affiliates) for the purpose of financing costs of acquisition, construction and equipping of (i) the NE Cargo/O'Hare International Airport Cargo Center, Phase 1 (the "NE Project"), consisting of multiple aircraft positions, a warehouse building with office space and related roadway and other improvements, expected to cost up to \$128 million (and to be financed with, Bonds in an aggregate principal amount not to exceed \$130,000,000), and (ii) the DHL Global Forwarding Center, consisting of a warehouse building with related

office space, truck dock positions and related roadway and other improvements, expected to cost up to \$52 million (and to be financed with Bonds in an aggregate principal amount not to exceed, \$70,000,000), each located at the Airport (the "DHL Project" and, collectively with the NE Project, the "Projects"); and

WHEREAS, it is intended that the interest on the Bonds will be excluded from gross income for federal income tax purposes; and

WHEREAS, it is intended that this ordinance shall constitute a declaration of intent to reimburse certain eligible expenditures for the Projects made prior to the issuance of the Bonds from the proceeds of the Bonds (if and when issued) within the meaning of Section 1.150-2 of the Treasury Regulations promulgated under the Internal Revenue Code of 1986, as amended (the "Treasury Regulations"); and

WHEREAS, the Borrower for the DHL Project desires to be able to finance the construction of the DHL Project separately from the financing structure in place for the other facilities located on the land covered by the Willow Creek Ground Lease and the City desires to accommodate the Borrower by permitting the Willow Creek Ground Lease to be divided into two ground leases, the terms of which two ground leases will be substantially similar to each other and to the existing Willow Creek Ground Lease, except as necessary and appropriate to have one such ground lease cover the land for the DHL Project (the "DHL Site") and cover the remaining land covered by the existing Willow Creek Ground Lease; and

WHEREAS, the Borrower wishes to lease the DHL Global Forwarding Center to Air Express International USA, Inc., an Ohio corporation d/b/a DHL Global Forwarding (the "Tenant") under a net lease of the DHL Site, and the City, Borrower and Tenant have proposed to enter into a Recognition, Non-Disturbance and Attornment Agreement (the "DHL SNDA") in substantially the form attached hereto as *Exhibit A*, to confirm their understanding with respect to the rights of Tenant and City in connection therewith; and

WHEREAS, the City has determined that it is necessary and advisable to authorize the execution and delivery of the DHL SNDA, and that the DHL SNDA is authorized by the Constitution and constitutes a valid public purpose thereunder;

NOW, THEREFORE,

Be It Ordained by the City Council of the City of Chicago:

Section 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

Section 2. The City intends to issue the Bonds and lend the proceeds thereof to the Borrower for the purpose of financing costs of the Projects. The maximum aggregate principal amount of Bonds which the City intends to issue for the Projects will not exceed Two Hundred Million Dollars (\$200,000,000), of which up to \$130,000,000 aggregate principal amount will be

issued with respect to the NE Project and up to \$70,000,000 aggregate principal amount will be issued with respect to the DHL Project.

Section 3. Certain costs may be incurred by the Borrower in connection with the Projects prior to the issuance of the Bonds. The City reasonably expects to reimburse such costs with proceeds of the Bonds.

Section 4. The costs to be reimbursed will be paid from funds of the Borrower which have been allocated to other purposes.

Section 5. This ordinance is consistent with the budgetary and financial circumstances of the City. No funds from sources other than the Bonds are, or are reasonably expected to be, reserved, allocated on a long-term basis or otherwise set aside by the City for costs of the Projects to be paid from the proceeds of the Bonds.

Section 6. This ordinance constitutes a declaration of official intent under Section 1.150-2 of the Treasury Regulations.

Section 7. The division of the Willow Creek Ground Lease into two ground leases, as described in the Recitals clauses of this Ordinance, is hereby authorized and the Mayor of the City and/or the Commissioner of the Chicago Department of Aviation (collectively, the "Authorized Officers") are hereby authorized to execute and deliver one or more new ground leases for and on behalf of the City and such other documentation as shall be reasonably necessary and appropriate to effectuate such division.

Section 8. The lease by the Borrower of the DHL Global Forwarding Center to Tenant is hereby found and declared to constitute a valid public purpose within the meaning of the Constitution. The form of the DHL SNDA attached hereto as *Exhibit A* is hereby approved in all respects. An Authorized Officer is hereby authorized to execute and deliver the DHL SNDA for and on behalf of the City. The DHL SNDA, as executed and delivered by the City, may contain such changes or revisions as shall be approved by an Authorized Officer, the execution and delivery thereof to constitute conclusive evidence of the City Council's approval of any and all changes or revisions therein or to other documents collateral thereto. No further approval or action of the City Council shall be necessary or required for the actions, executions and deliveries contemplated in and directed in this Section 8 to be effective, and any such actions, executions and deliveries will constitute the legal and validly binding actions of the City.

Section 9. This ordinance is adopted pursuant to the powers of the City as a home rule unit under Article VII, Section 6(a) of the Constitution. The Authorized Officers, for and on behalf of the City, shall be, and hereby are, authorized and directed to do any and all things necessary to effect the performance of all obligations of the City under and pursuant to this ordinance and the performance of all other acts of whatever nature necessary to effect and carry out the authority conferred by this ordinance. The Authorized Officers and other officers, agents and employees of the City are hereby further authorized and empowered for and on behalf of the City, to execute and deliver all papers, documents, certificates and other instruments that may be required to carry out the authority conferred by this ordinance.

Section 10. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

Section 11. This ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor of the City.

RECOGNITION, NON-DISTURBANCE AND ATTORNMENT AGREEMENT

THIS RECOGNITION, NON-DISTURBANCE AND ATTORNMENT AGREEMENT ("Agreement") is made as of _____, 2014 by and between AIR EXPRESS INTERNATIONAL USA, INC., an Ohio corporation d/b/a DHL Global Forwarding ("Tenant"), AERO O'HARE, LLC, an Illinois limited liability company ("Landlord"), and THE CITY OF CHICAGO, a municipal corporation (the "City").

RECITALS

WHEREAS, Landlord is the owner of a ground leasehold interest in and to that certain real property described on Schedule 1 attached hereto, together with the improvements thereon (the "Property") pursuant to that certain Lease at Chicago O'Hare International Airport dated February 5, 2002, as amended by that certain Amendment to Ground Lease dated June 14, 2002 (collectively, the "Master Lease") entered into between Landlord, as lessee, and City, as lessor;

WHEREAS, Landlord and Tenant have entered into a certain Net Lease dated _____, 2014 (as the same may hereafter be amended, modified, renewed, extended or replaced, the "Space Lease"), whereby Landlord leases to Tenant a portion of the Property (such portion, as described more completely in the Lease, the "Premises"); and

WHEREAS, City, Landlord, and Tenant, desire to confirm their understanding with respect to the Space Lease, the Property, the Premises, the Master Lease, and the rights of Tenant and City in connection therewith.

NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

AGREEMENTS

1. Space Lease is Subordinate. Tenant hereby acknowledges and agrees that the Space Lease and the leasehold estate created thereby and all of Tenant's rights thereunder are subordinate and subject to the Master Lease and its terms and conditions, and to any and all renewals, modifications, consolidations, replacements and extensions thereof; provided, as

between Landlord and Tenant only, the foregoing shall not in any way be construed to amend or modify Landlord's or Tenant's expressed rights, obligations or liabilities under the Space Lease with respect to any amendments or modifications to the Master Lease made and/or entered into after the date of the Space Lease. This Agreement shall be effective upon the full execution and delivery hereof by each of Landlord, Tenant and City. Upon the full execution and delivery of this Agreement, City and Landlord shall cause an original executed copy of this Agreement to be recorded in the Official Records of Cook County, Illinois, and also shall, at no expense to Tenant, deliver to Tenant a conformed copy of the recorded Agreement (which shall contain all applicable recording information).

2. Recognition, Non-Disturbance and Attornment. In the event that the Master Lease should expire or terminate prior to the Space Lease, it is agreed that, subject to the terms and conditions of this Agreement, and so long as at the time of such expiration or termination the Tenant is not in default under the Space Lease (beyond all applicable notice and cure periods), then at the time of that expiration or termination: (a) City shall not disturb Tenant in Tenant's possession of the Premises and City shall recognize Tenant as its direct tenant of the Premises under the then applicable terms and conditions of the Space Lease, and the Space Lease shall thereafter continue in full force and effect as a direct lease between City and Tenant, and (b) Tenant agrees to attorn to City and to recognize City as Tenant's landlord, upon the then applicable terms and conditions of the Space Lease.

3. Limitations on City's Liability. In the event of the recognition and attornment described above in Section 2, Tenant and City hereby agree that City shall not be (a) liable for any act or omission of the Landlord under the Space Lease; (b) liable for the performance of Landlord's covenants under the Space Lease which arise and accrue prior to City succeeding to the interest of Landlord under the Space Lease or acquiring such right to possession including, without limitation, performance of the Landlord's obligations under the Work Letter; (c) subject to any offsets or defenses which the Tenant may have at any time against Landlord excluding any expressed abatement rights contained in the Space Lease which may be applicable, or continue to be applicable, after City succeeds to Landlord's interest in and to the Space Lease; (d) bound by any rent which the Tenant may have paid previously for more than one (1) month; (e) liable for the performance of any covenant of Landlord under the Space Lease which is capable of performance only by Landlord; or (d) liable for (i) construction or restoration by Landlord of any improvements to the Premises, or to any other improvements on or to the Premises, or (ii) payment by Landlord of any allowances for construction or other cash payments. Without limiting the foregoing, City and Tenant hereby agree that in all events the City's liability to Tenant shall be limited as provided in Sections 7.1(c), 7.1(e), 7.1(f), 7.1(g), 7.1(h), 14.4 and 15.13 of the Master Lease.

4. Subsequent Transfer by City. In the event of the recognition and attornment described above in Section 2, Tenant hereby agrees that the City shall have the right at any time, by providing written notice thereof to the Tenant, to assign its rights, title and interest in and to the Premises and under the Space Lease to a third party selected by the City, and from and after the effective date of such assignment, the City shall no longer have any obligation or liability under the Space Lease.

5. Landlord Default - Space Lease. If the Landlord defaults under any provision of the Space Lease, and if such Landlord default would entitle Tenant to terminate the Space Lease, then Tenant agrees to provide notice to the City of such continuing default and any right to terminate Tenant may have on account thereof, and City may elect, in its sole and absolute discretion, to cure any such default within a period commensurate with any such cure period afforded to Landlord under the Space Lease, in all events not to exceed sixty (60) days. The foregoing shall not in any way limit any of Tenant's other rights or remedies under the Space Lease with respect to any Landlord default thereunder, and shall only limit, to the extent expressly set forth above in this paragraph, Tenant's right to terminate the Space Lease on account of a Landlord default thereunder.

6. Landlord Default - Master Lease. The City agrees to endeavor to provide Tenant with written notice of any Landlord default under the Master Lease which (a) relates to the Premises or any common areas of the Property which may be used by Tenant in connection with its operations, or (b) could lead to a termination of the Master Lease. So long as the Landlord default in question is not caused by a Tenant default under the Space Lease, then the City agrees that Tenant may, but shall not be required to, cure such default on Landlord's behalf, and City agrees to accept Tenant's performance in such instance(s). Tenant's right to perform such obligations on Landlord's behalf, and its remedies and recoveries related thereto, are set forth, if at all, in the Space Lease, and with respect to the foregoing, as between Tenant and Landlord, the terms and conditions of the Space Lease shall control. The City retains all remedies under Section 10.2 of the Master Lease for all Events of Default under Section 10.1 of the Master Lease, including but not limited to the failure of Landlord to pay all Rent required under the Master Lease, if such failure is not cured by Tenant.

7. Notice. Any notice or other communication made or given by any party in connection with this Agreement shall be sent by registered or certified mail, postage prepaid, return receipt requested, or by overnight courier service addressed to the other parties at their respective addresses set forth on the signature pages below, or, at such other addresses as the parties shall specify in writing. Such notices shall be deemed given on the date of receipt (or refusal) of delivery of said notice.

8. Miscellaneous.

(a) City's enforcement of any provisions of this Agreement or the Master Lease shall not entitle Tenant to claim any interference with the contractual relations between Landlord or Tenant or give rise to any claim or defense against City with respect to the enforcement of such provisions.

(b) This Agreement shall inure to the benefit of the parties hereto and their respective successors and assigns.

(c) The captions appearing under the paragraph number designations of this Agreement are for convenience only and are not a part of this Agreement and do not in any way limit or amplify the terms and provisions of this Agreement.

(d) If any portion or portions of this Agreement shall be held invalid or inoperative, then all of the remaining portions shall remain in full force and effect, and, so far as is reasonable and possible, effect shall be given to the intent manifested by the portion or portions held to be invalid or inoperative.

(e) This Agreement shall be governed by and construed in accordance with the laws of the State in which the Property is located.

(f) This Agreement may be executed in any number of separate counterparts, each of which shall be deemed an original, but all of which, collectively and separately, shall constitute one and the same agreement.

(g) This Agreement cannot be altered, modified, amended, waived, extended, changed, discharged or terminated orally or by any act on the part of Tenant, Landlord or City, but only by an agreement in writing signed by all parties hereto.

(h) In the event of a dispute between any of the parties hereto over the meaning of this Agreement, all parties hereto shall be deemed to have been the drafter hereof, and any applicable law that states that contracts are construed against the drafter shall not apply.

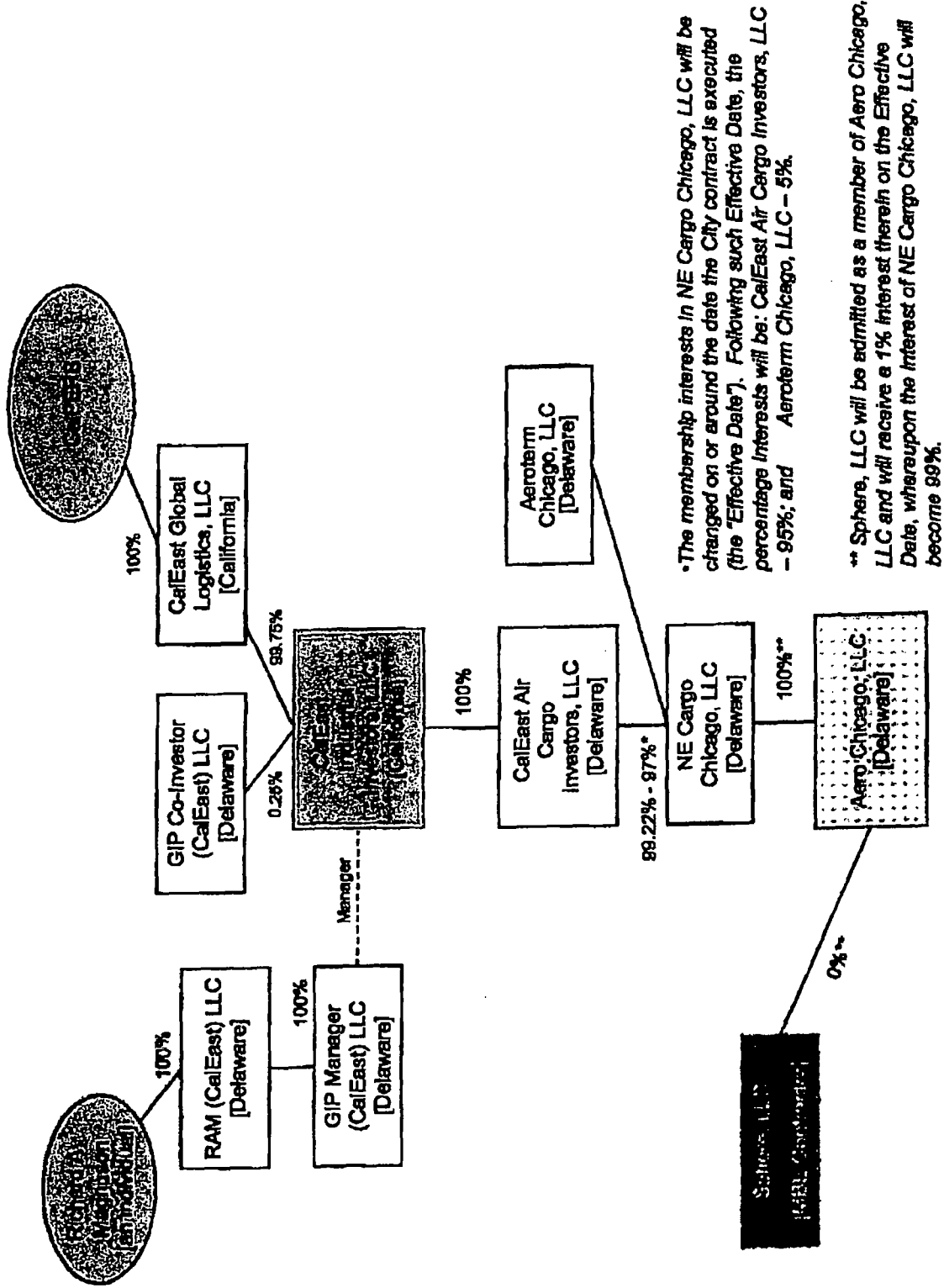
