South Central Park Avenue, West 25<sup>th</sup> Street, the alley next East and parallel to South Central Park Avenue, a line 34.35 feet South and parallel to West 25<sup>th</sup> Street.

to those of a B3-2 Community Shopping District.

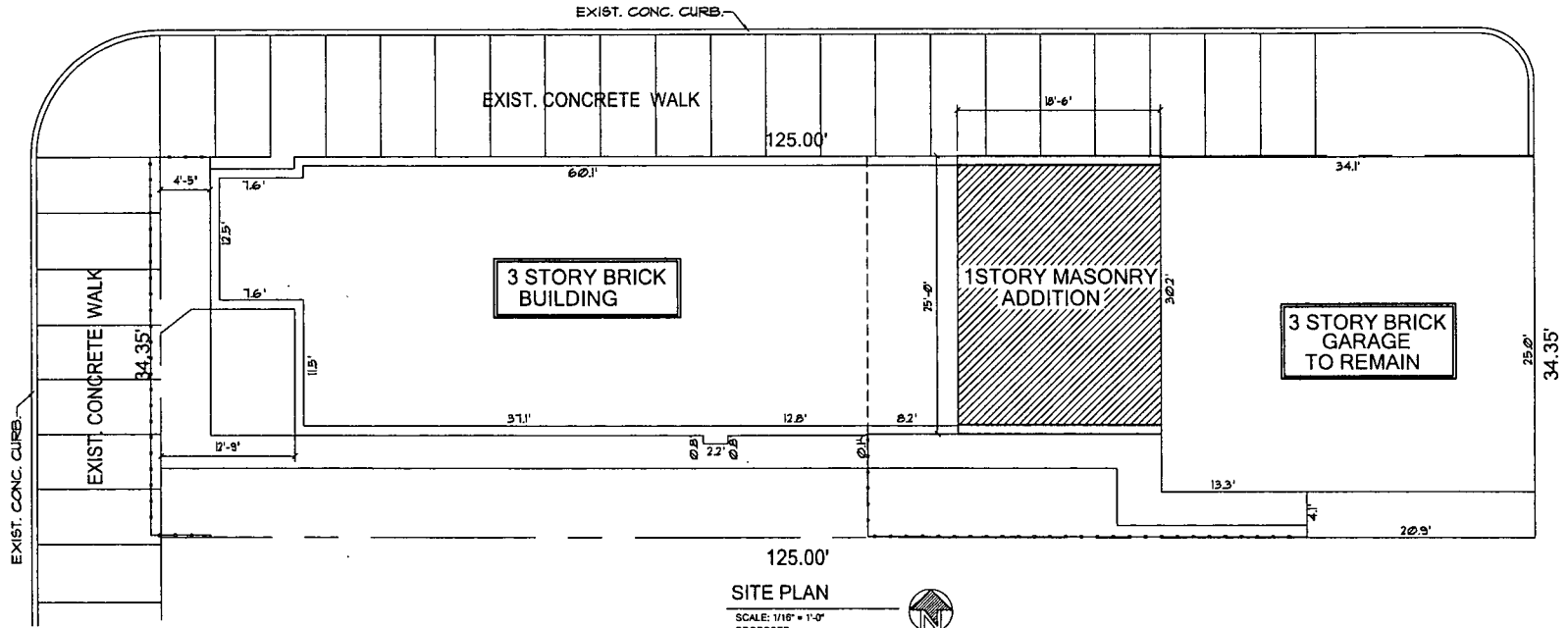

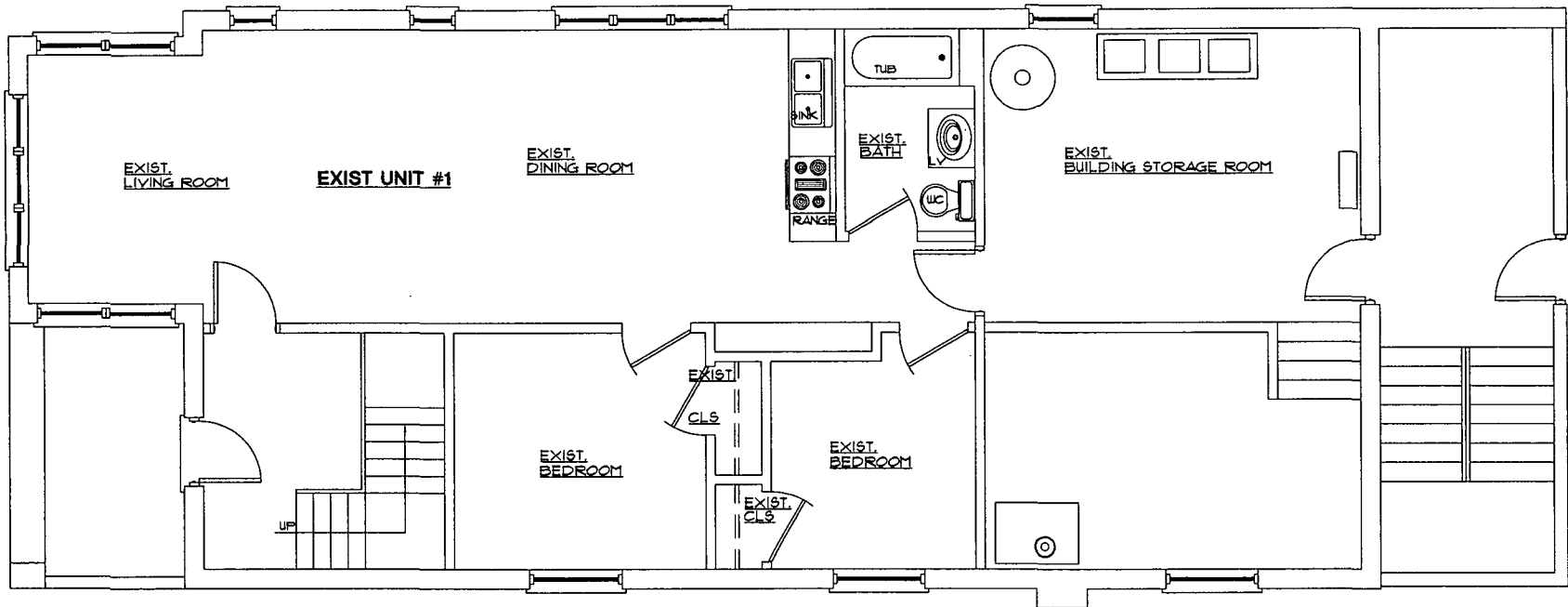
S. CENTRAL PARK AVENUE

SITE PLAN

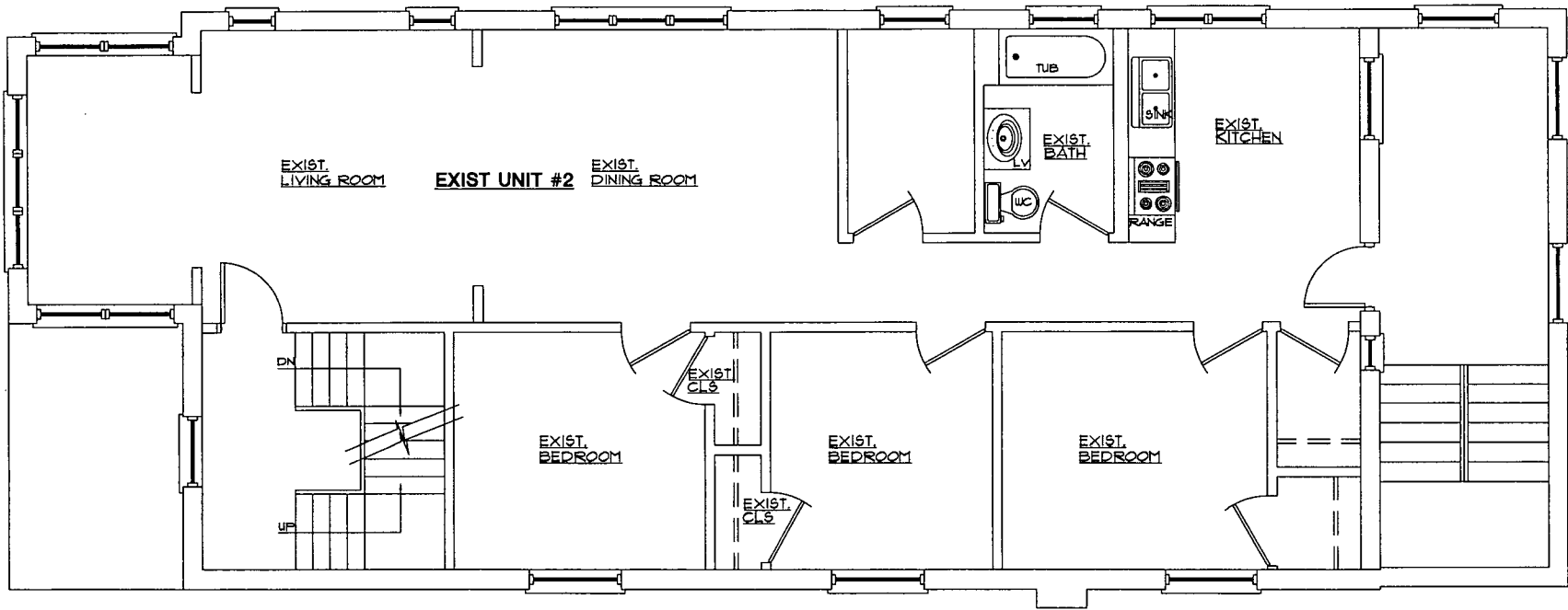

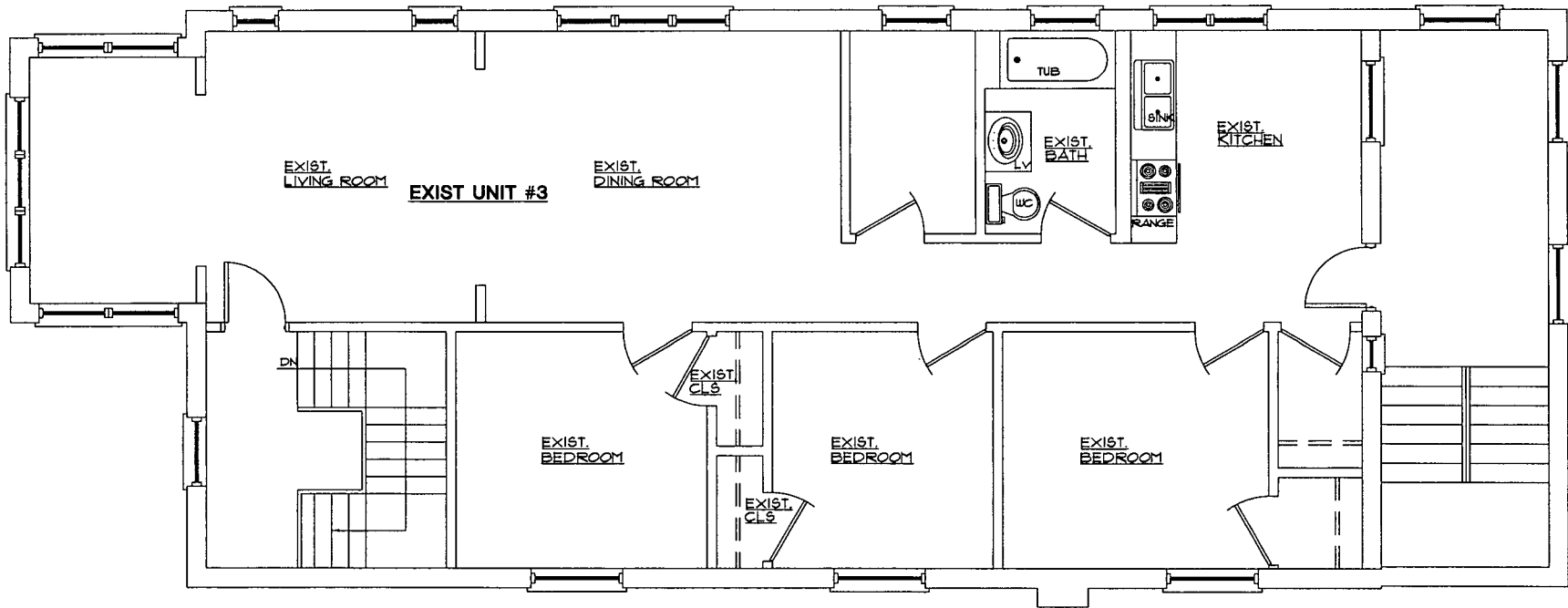
**1 FIRST FLOOR PLAN**

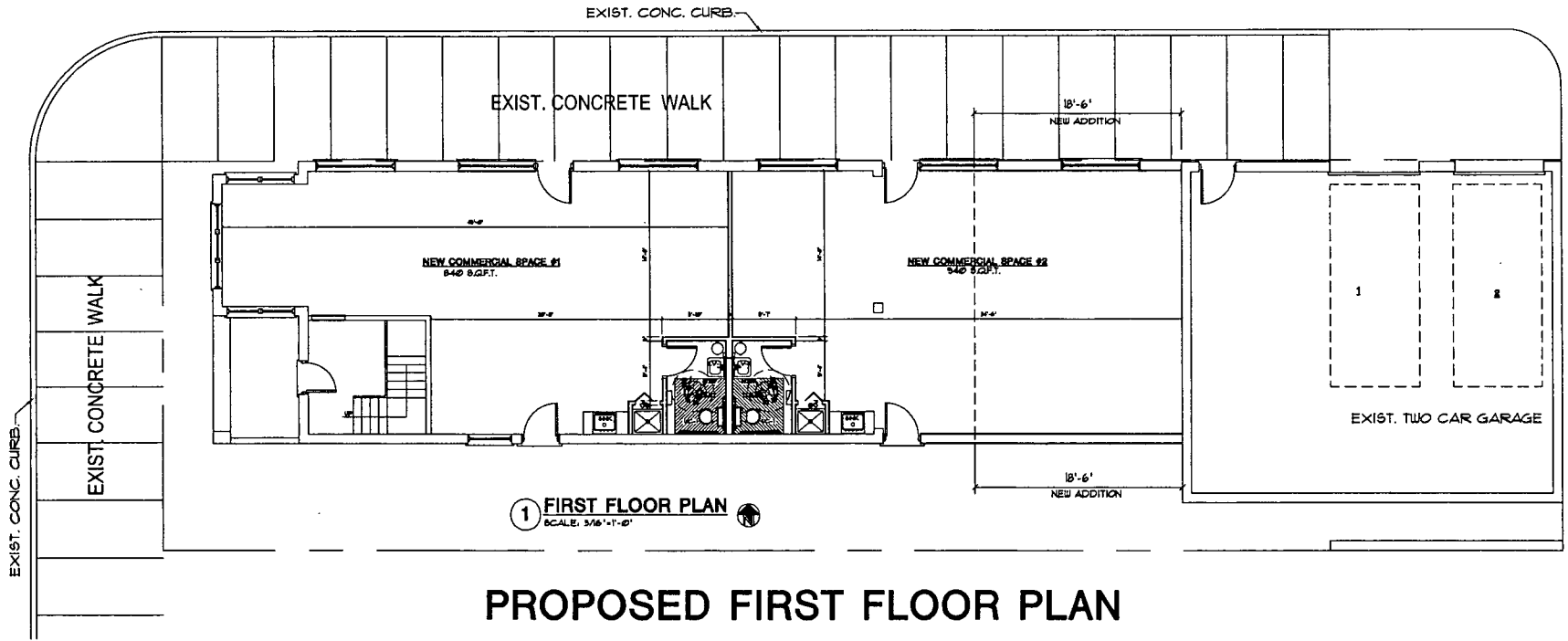


**3** **THIRD FLOOR PLAN**

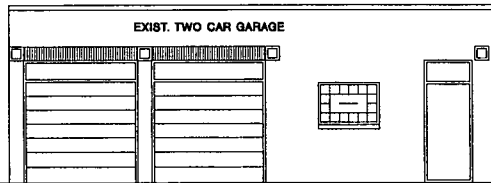

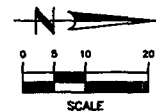
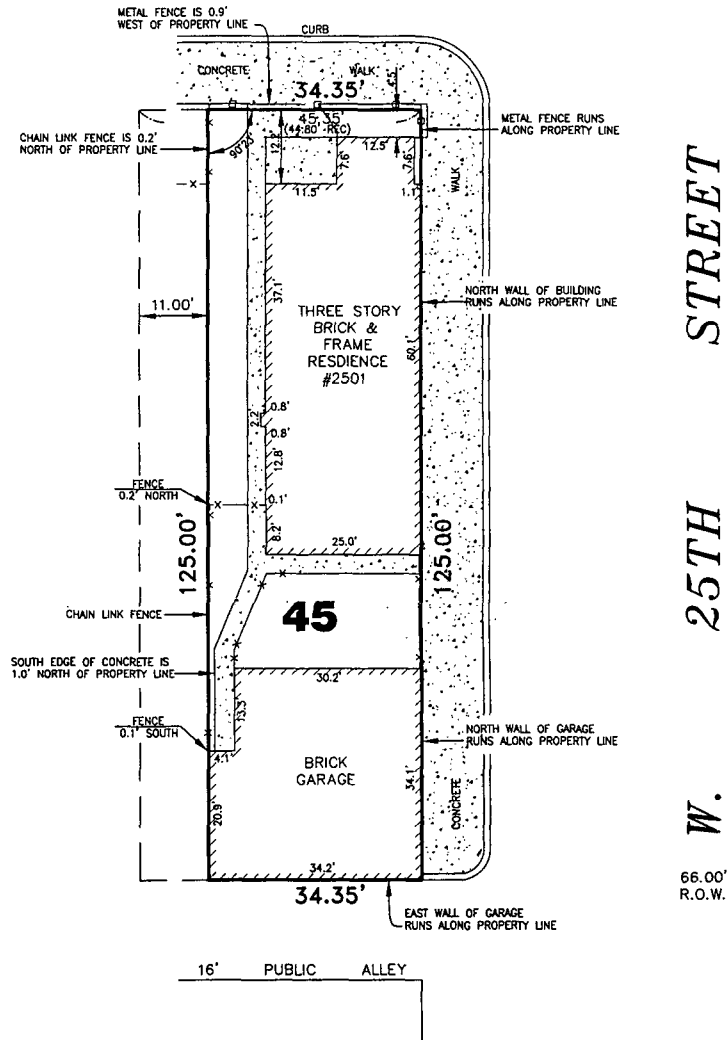
