ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the **RS-3 Residential Single-Unit (Detached Housing) District**, as shown on Map 6-H in the area bounded by:

West 23rd Place; South Hoyne Avenue; a line 49.00 feet South of West 23rd Place; and the alley next West of and parallel to South Hoyne Avenue,

to those of **B2-3 Neighborhood Mixed Use District**

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

**NARRATIVE AND PLANS
FOR THE PROPOSED TYPE 1 APPLICATION
2334-2336 SOUTH HOYNE AVENUE**

The Application on behalf of the current property Owner, Diamond Properties Group, LLC, is for a Zoning Map Amendment from RS-3 Residential Single Unit (Detached) District to B2-3 Neighborhood Mixed-Use District for purposes of subdividing one zoning lot into two zoning lots from 49' x 104.50 into two zoning lots of 24' x 104.50 and 25' x 104.50 respectively (the property is a Zoning Lot as defined in Section 17-17-02197).

On the vacant lot, the Applicant intends to construct a three-story, three dwelling unit building with three (3) off street parking spaces. There will be **no change to the existing three (3) dwelling unit building at 2334 South Hoyne**. The footprint of the **new Building at 2336 South Hoyne** shall be approximately 19 feet by 70 feet in size, and the new building shall be 30 feet 2 inches high, as defined by City Code.

SPECIFIC CRITERIA FOR THIS EQUITABLE TRANSIT SERVED LOCATION

Two parking spaces are provided at 2334 South Hoyne (there are required for three dwelling units). 2334 South Hoyne is an Equitable Transit Served Location under 17-10-0102-B since it is 704 feet north of the Blue Island Route 60 CTA Bus Line:

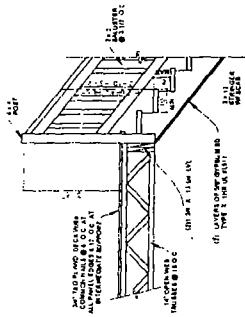
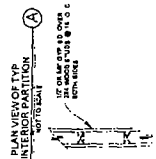
1. The Project complies with Section 17-10-0102-B, located 704 feet north of the Blue Island/60 CTA Bus route;
2. The site is not a Pedestrian Street under 17-3-0504; (non-accessory parking abutting a Pedestrian Street is not applicable);
3. The Project complies with the general goals set forth in the Transit Friendly Development Guide since it is located in a Local Activity Center Area as an in-fill development and both on a qualified CTA Bus route and in close proximity to the Blue Line;
4. The Project will provide:
 - a. **2334 South Hoyne:** Two (2) parking spaces for three (3) dwelling units;
 - b. **2336 South Hoyne:** Three (3) parking spaces for three (3) dwelling units.
5. The Project complies with the Travel Demand Study and Management Plan rules of the Chicago Department of Transportation.

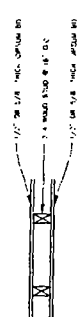
THIRD FLOOR PLAN

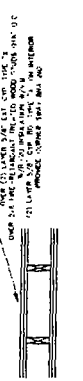

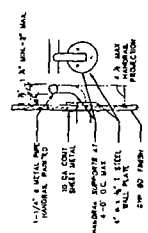
