BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 3-H in the area bounded by

The public alley next north of and parallel to West Chicago Avenue; a line 31.0 feet west of and parallel to North Ashland Avenue; West Chicago Avenue; and a line 81 feet west of and parallel to North Ashland Avenue.

To those of a B3-1 Community Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed than on or about March 30, 2018, the undersigned will file an application for a change in zoning from B1-2 to B3-1 on behalf of Chicago Avenue Hospitality, LLC, d/b/a Beatnik, for the property located at 1604-1608 W. 
