Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to Sixteen Condo Association, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, nine (9) Balcony(s) projecting over the public right-of-way adjacent to its premises known as 3443 N. Lincoln Ave..

Said Balcony(s) at N Lincoln Ave measure(s):

One (1) at three (3) feet in length, and nine point seven five (9.75) feet in width for a total of twenty-nine point two five (29.25) square feet.

One (1) at three (3) feet in length, and twelve point seven four (12.74) feet in width for a total of thirty-eight point two two (38.22) square feet.

One (1) at three (3) feet in length, and nine point seven four (9.74) feet in width for a total of twenty-nine point two two (29.22) square feet.

One (1) at three (3) feet in length, and nine point seven five (9.75) feet in width for a total of twenty-nine point two five (29.25) square feet.

One (1) at three (3) feet in length, and twelve point seven four (12.74) feet in width for a total of thirty-eight point two two (38.22) square feet.

One (1) at three (3) feet in length, and nine point seven four (9.74) feet in width for a total of twenty-nine point two two (29.22) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1139886 herein granted the sum of six hundred seventy-five (\$675.00) per annum in advance.

A 25% penalty will be added for payments received after due date.


