south of and parallel to West 32nd Place; and South Carpenter Street;

to those of an RM5 Residential Multi-Unit District is hereby established in the
area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and
due publication.

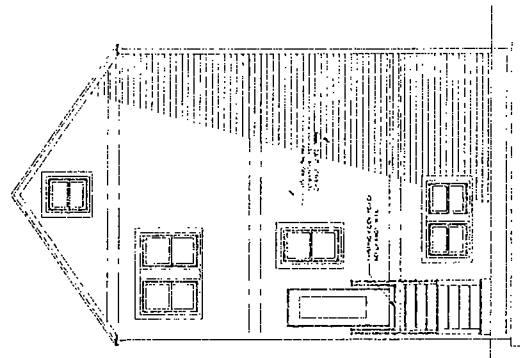




3 SIDE (SOUTH) ELEVATION-EXISTING

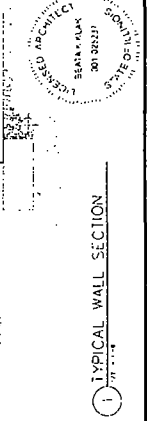
