Section 1:

The ordinance passed by the City Council of the City of Chicago for UNIVERSITY COMMONS V CONDO ASSN on 02/15/2012, and printed upon page 20794 of the Journal of Proceedings of the City of Chicago is here by Amended by deleting the words
