Section 1:

The ordinance passed by the City Council of the City of Chicago for **UNIVERSITY COMMONS V CONDO ASSN** on **02/15/2012**, and printed upon page **20794** of the Journal of Proceedings of the City of Chicago is here by Amended by deleting the words

“ten (10) Concrete Area Well(s)

Said Area Well(s) at W. 15th St measure(s):

Four (4) at five (5) feet in length, and six point four (6.4) feet in width for a total of one hundred twenty-eight (128) square feet.

Said Area Well(s) at W. 15th St measure(s):

Six (6) at five (5) feet in length, and ten point four (10.4) feet in width for a total of three hundred twelve (312) square feet.

The sum of four thousand (\$4,000.00) per annum in advance.”

and inserting in their place the words

“one (1) Concrete Area Well

Said Area Well at W. 15th St Measure:

Forty (40) feet in length and eight (8) inches in width.

The sum of four hundred (\$400.00) per annum in advance.”


