*Be It Ordained by the City Council of the City of Chicago*

SECTION 1 Permission and authority are hereby given and granted to JOHN MARSHALL LAW SCHOOL, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Vault(s) under the public right-of-way adjacent to its premises known as 19 W Jackson Blvd

Said Vault(s) at W JACKSON BLVD measure(s)

One (1) at one hundred seventeen point four two (117 42) feet in length, and ten point four two (10 42) feet in width for a total of one thousand two hundred twenty-three point five two (1223 52) square feet

Said Vault(s) at S PLYMOUTH CT measure(s)

One (1) at ninety point two five (90 25) feet in length, and seven point five eight (7 58) feet in width for a total of six hundred eighty-four point one (684 1) square feet

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination)


This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago

The grantee shall pay to the City of Chicago as compensation for the privilege #1097902 herein granted the sum of six thousand forty-eight (\$6,048 00) per annum in advance

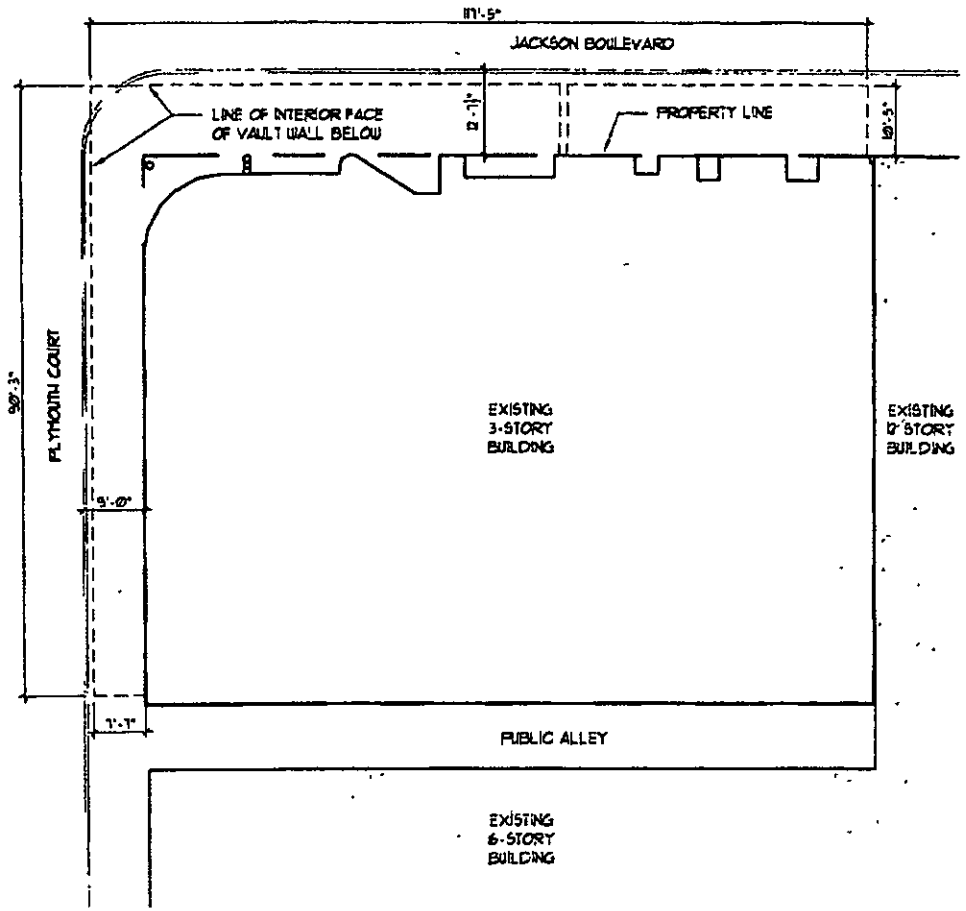
A 25% penalty will be added for payments received after due date

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way

Authority herein given and granted for a period of five (5) years from and after Date of Passage

(Introduced to City Council on October 5, 2011)

1. The **John Marshall Law School** ordinance amount was changed/substituted to \$6,048.00 per the request of Stan Adams in the Department of Business. Per Mr. Adams, the previous amount of \$2,048.00 was incorrect.
  2. In the **Eddystone Condominium Homes, Inc.** ordinance, the street was incorrectly stated. Ald. Tunney's office was contacted and Ald. Tunney confirmed that the name of the street should be reflected as "Melrose Street", **not** "Montrose Drive". Also, please note that the location of the condominium is located in the 44<sup>th</sup> ward, and **not** the 46<sup>th</sup> ward, which Ald. Tunney corrected when the ordinance was introduced.
