SECTION 1 Permission and authority are hereby given and granted to ELYSIAN HOTEL, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Manhole(s) under the public right-of-way adjacent to its premises known as 11 E Walton St

Said Manhole(s) at E Walton measure(s)

One (1) at one (1) foot in length, and four (4) feet in width for a total of four (4) square feet

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination) and Department of Water Management

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago

The grantee shall pay to the City of Chicago as compensation for the privilege #1098174 herein granted the sum of four hundred (\$400 00) per annum in advance

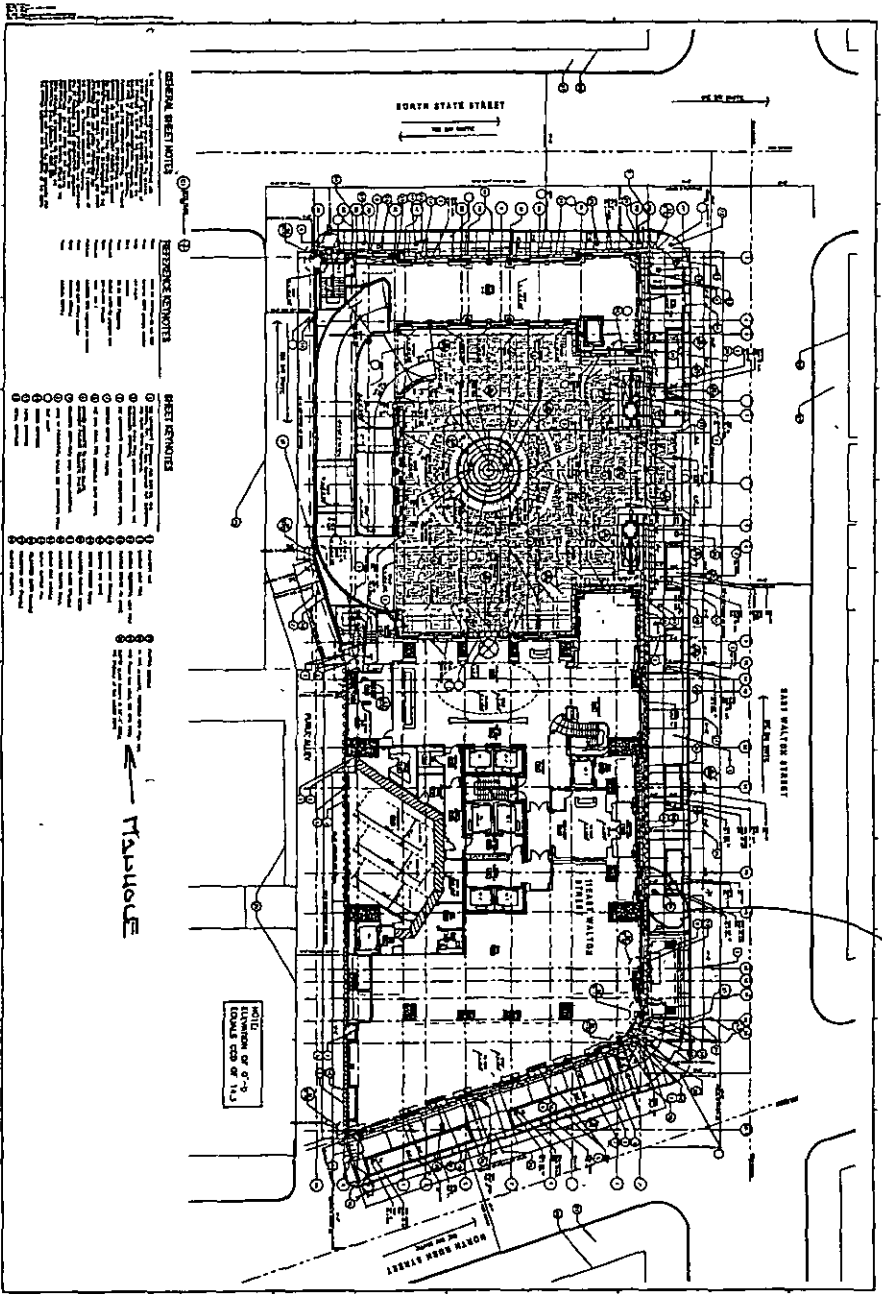
A 25% penalty will be added for payments received after due date

SECTION 1. Permission and authority are hereby given and granted to RANDOLPH WINE CELLARS, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Wind Screen(s) on the public right-of-way adjacent to its premises known as 1415 W Randolph St

Said Wind Screen(s) at Randolph Street measure(s)

One (1) at four (4) feet in length, and five (5) feet in width for a total of twenty (20) square feet

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development)

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago


The grantee shall pay to the City of Chicago as compensation for the privilege #1098210 herein granted the sum of four hundred (\$400 00) per annum in advance

A 25% penalty will be added for payments received after due date

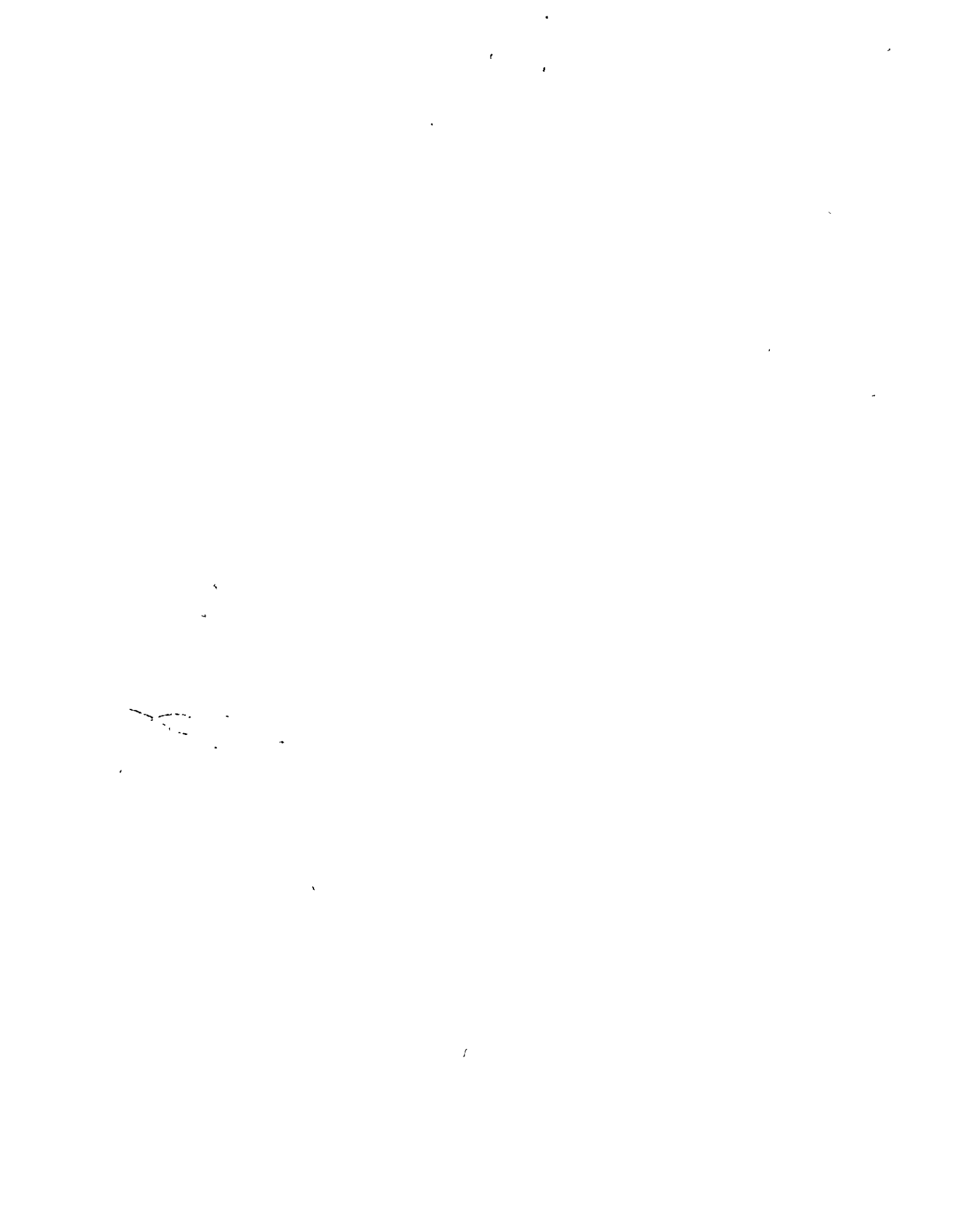
