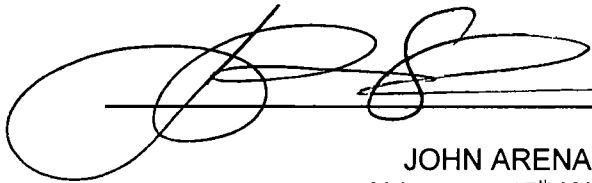
Senior Citizen's Sewer Refund
