**ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M2-3, Light Industry District symbols and indications as shown on Map No. 7-H in the area bounded

A line 307.83 feet southeast of West Diversey Parkway (as measured along the northeast line of North Clybourn Avenue); the public alley next northeast of and parallel to North Clybourn Avenue; a line 482.83 feet southeast of West Diversey Parkway (as measured along the northeast boundary line of North Clybourn Avenue); North Clybourn Avenue

to those of a C1-3, Neighborhood Commercial District.

Section 2. This ordinance takes effect after its passage and approval.
