ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on 8-F in the area bounded by

A line 150.0 feet south of and parallel to West 32nd Street, South Princeton Avenue, a line 225.0 feet south of and parallel to West 32nd Street; and the alley next west of and parallel to South Princeton Avenue

to those of a B2-2 Neighborhood Mixed-Use District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

Reason for rezoning the property to meet the bulk and density requirements of the B2-2 Neighborhood Mixed-Use District for the construction of a new 8,522 sq. ft. single-family house and alterations to an existing 7,822.50 ft., 2-story, 3 dwelling-unit-and-garage building at the rear of the lot. The structures will be linked by a two-story substantial connection. Four accessory and four non accessory parking spaces will be provided.

Applicant proposes to demolish an existing single-dwelling unit house and replace it with a 3-story-and-basement, 8,522 sq. ft., single-family residence. The new house will be connected to an existing 7,822.50 sq. ft., 2-story combined 3-dwelling unit-and-garage building at the rear of the lot. A 2-story substantial connection will link the buildings. A 1-story section portion of the garage/residential building, at southern end of of it, will be razed. There will be a total of 4 dwelling units on the property. Four accessory and four non-accessory parking spaces will be provided in the garage building. Parking will be accessed from the alley only. An existing driveway at Princeton Avenue will be removed. There will be no commercial use of the property. The height of the new building will be 42'.






In accordance with Section 17-13-0107 of the Chicago Zoning Ordinance, please be informed that on or about January 26, 2022, the undersigned will file an application for a change in zoning from an RT4 Residential Two-Flat, Townhouse to a B2-2 Neighborhood Mixed-Use District on behalf of Frank Ruffolo for the property located at 3216 South Princeton Avenue, Chicago, IL 60616 (the "Subject Property").

The Applicant intends to demolish an existing single-dwelling unit house and replace it with a 3-story-and-basement, 8,522 sq. ft., single-family residence to create one building on the zoning lot and convert from 3 to 4 dwelling units on the property. The new house will be connected to an existing 7,822.50 sq. ft., two-story former commercial garage building located at the rear of the lot. A two-story entrance will provide a substantial connection between the buildings. The garage building has three existing residential units which will be retained. Four accessory and four non-accessory parking spaces will be provided in the garage building. Parking will be accessed from the alley only. An existing driveway at Princeton Avenue will be removed. There will be no commercial use of the property.


