MACERICH MANAGEMENT

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to MACERICH MANAGEMENT, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Panel(s) projecting over the public right-of-way adjacent to its premises known as 520 N. Michigan Ave..

Said Panel(s) at E. Grand measure(s):

One (1) at two (2) feet in length, and twelve (12) feet in width for a total of twenty-four (24) square feet. Existing panel shall be approximately seven (7) feet six (6) inches in height.

Said Panel(s) at N. Rush measure(s):

One (1) at two (2) feet in length, and twelve (12) feet in width for a total of twenty-four (24) square feet. Existing panel is approximately seven (7) feet six (6) inches in height.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1123790 herein granted the sum of two hundred (\$200.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

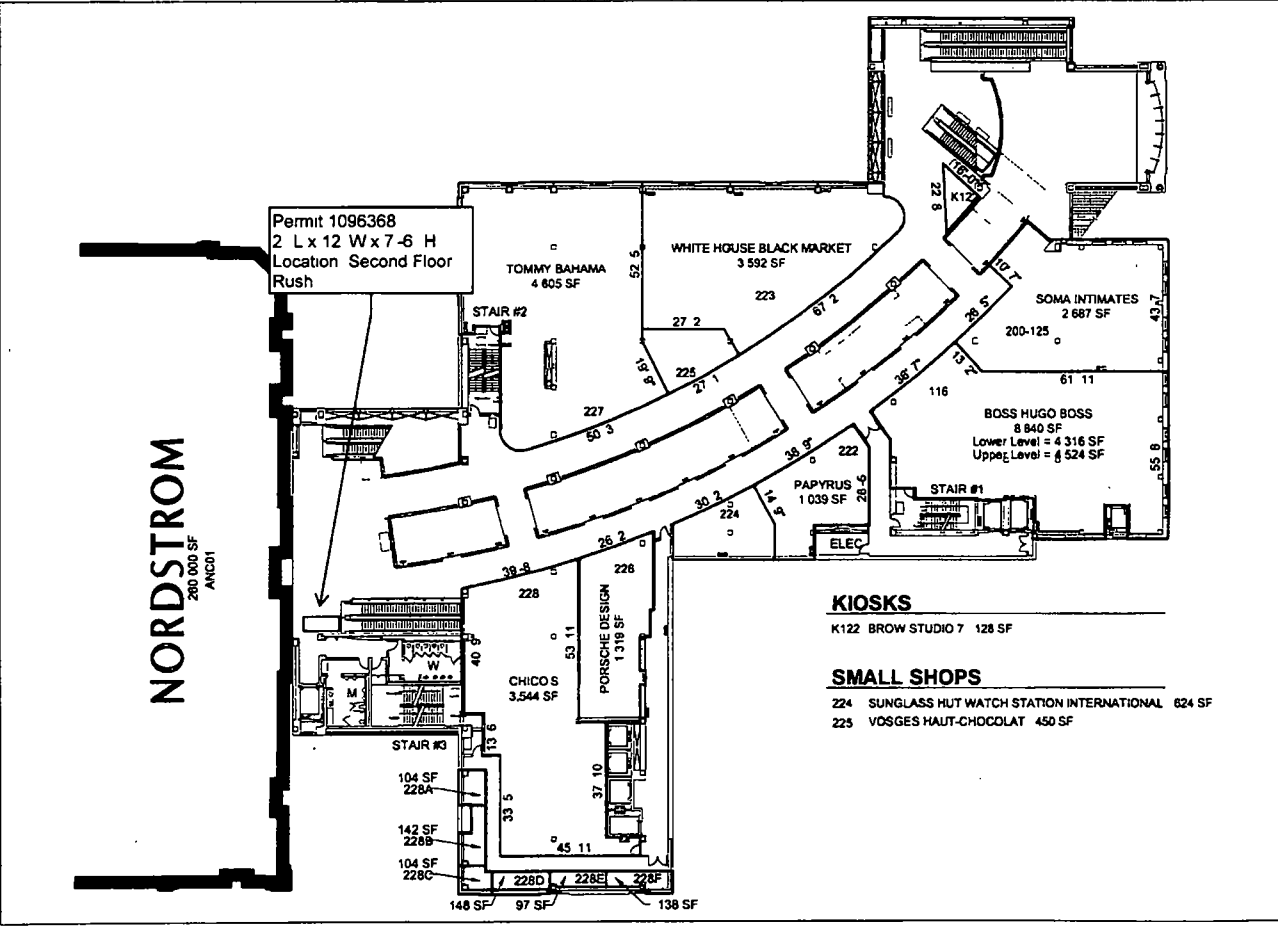
