***WHEREAS***, The hard work, sacrifice and dedication of Preston P. "Bud" Smuda serve as an example to all; and



***WHEREAS***, Preston P. "Bud" Smuda will be dearly missed and fondly remembered by his many relatives, friends and admirers; and


**WHEREAS**, To his beloved family, Preston P. "Bud" Smuda imparts a legacy of faithfulness, service and dignity; now, therefore
