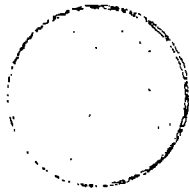

ORDINANCE

WHEREAS, The City of Chicago (“the City”) wishes to establish a three-year designation cycle for municipal depositories, with the first three-year designation cycle to commence on January 1, 2016; and

WHEREAS, If the City Council designates a financial institution as a municipal depository pursuant to Article V of Chapter 2-32 of the Municipal Code of Chicago (“the Code”), and such designation takes legal effect in calendar year 2015, the City intends for such designation to remain in effect until the first three-year designation cycle that begins on January 1, 2016 ends, except as otherwise provided in this Ordinance; and

WHEREAS, On November 28, 2014, the City Comptroller advertised for bids from national and state banks and federal and state savings and loan associations for the payment of interest upon the funds of the City and of the Chicago Board of Education (the “Board”) in accordance with existing Section 2-32-400 of the Code; and

WHEREAS, The City Comptroller received bids from three financial institutions seeking to be designated as a municipal depositories pursuant to this Code and determined that each of these three financial institutions is eligible to be designated as a municipal depository of the City and the Board; and

WHEREAS, The City Comptroller is required under this Code to report such findings to the City Council; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The heading of Article V of Chapter 2-32 of the Municipal Code of Chicago is hereby amended by deleting the language stricken through and by inserting the language underscored, as follows:

ARTICLE V. MUNICIPAL ~~DEPOSITARIES~~ DEPOSITORIES (~~2-32-400 et seq.~~)

SECTION 2. Section 2-32-400 of the Municipal Code of Chicago is hereby renumbered as Section 2-32-405 and amended by deleting the language stricken through and by inserting the language underscored, as follows:

~~2-32-400~~ 2-32-405 ~~Bids awarded annually~~ — **Conditions for awarding bids.**

(a) (1) Advertising for bids. ~~Each year, at least once before the first day of December, it shall be the duty of the comptroller at least once in each year before the first day of~~

~~December to advertise for bids from national and state banks and federal and state savings and loan associations for the payment of interest upon the funds of the City of Chicago and the Chicago Board of Education to be deposited in banks and savings and loan associations from federally insured financial institutions seeking to be designated as municipal depositories.~~ Provided, however, that Chicago local school funds which are designated by the Chicago Board of Education as school internal accounts which, in general, are funds raised and expended for educational programs and for the benefit of students, are specifically shall be excluded from the funds of the Chicago Board of Education that are subject to the provisions of this Article V.

(2) *Transmittal of bids to city council.* ~~Such bids shall be reported by the comptroller~~ Each year, no later than the fifteenth day of December, the comptroller shall transmit to the city council, for its information and consideration, not later than the fifteenth day of December of each year, all bids conforming to this Article V that have been submitted during the open window, as defined in Section 2-32-400, by financial institutions seeking to be designated as municipal depositories to the end that an award or awards may be made upon such bids by the city council before the beginning of each fiscal year.

(3) *Awarding bids – Designation of municipal depositories.* The city council shall consider the bids transmitted to it by the comptroller pursuant to subsection (a)(2) of this section with the goal of making an award or awards upon such bids before the beginning of each fiscal year. Such Any such awards shall be made to the highest and best responsible bidder or bidders bidder(s) meeting the requirements of this Article V. The city council shall have the power to reject any and all bids transmitted to it by the comptroller and to designate as many depositories municipal depositories from any such bids as it deems necessary for the protection of the city's interests. Only Provided, however, that only regularly organized state or national banks financial institutions insured by the Federal Deposit Insurance Corporation or federal or state savings and loan associations insured by the Federal Savings and Loan Insurance Corporation may shall be designated as depositories municipal depositories.

(b) (1) *Three-year designation cycle established.* On January 1, 2016, and every three years thereafter, a three-year designation cycle shall commence for municipal depositories. The first three-year designation cycle shall begin on January 1, 2016 and shall end at midnight on December 31, 2018; the second three-year designation cycle shall begin on January 1, 2019 and shall end at midnight on December 31, 2021, and so on. The adoption of an ordinance designating municipal depositories for any three-year designation cycle shall be deemed, by operation of law effective ten days after such ordinance takes legal effect, to repeal all prior ordinances designating municipal depositories.

(2) Off-cycle bids – Permitted. A financial institution shall be permitted to submit a bid to be designated as a municipal depository after a three-year designation cycle has commenced, but before such three-year designation cycle ends.

(3) Duration of municipal depository designation. If a financial institution is designated as a municipal depository for a three-year designation cycle, or if a financial institution is designated as a municipal depository after a three-year designation cycle has commenced, but before such three-year designation cycle ends, such designation shall: (i) apply from the date that the designation takes legal effect; and (ii) except as otherwise provided in subsections (e) or (g) of this section, remain in effect until ten days after an ordinance designating municipal depositories for the next three-year designation cycle takes legal effect.

(c) Legal effect of failure to designate. If, prior to the commencement of any three-year designation cycle, the city council fails to enact an ordinance designating municipal depositories for such three-year designation cycle, the municipal depositories in existence before midnight on the last day of the year immediately preceding commencement of the applicable three-year designation cycle shall retain their designation as municipal depositories until ten days after any such ordinance takes legal effect, except as otherwise provided in subsections (e) or (g) of this section.

(d) Post-designation annual disclosure – Required. Each financial institution that is designated as a municipal depository before or during the first two years of any three-year designation cycle shall be required, during each calendar year following the calendar year in which such designation takes legal effect, to submit to the comptroller and treasurer, by a date certain and in the manner the comptroller shall prescribe, the information required under Section 2-32-425. Such information shall be current and complete as of the required submission date.

(e) Decertification of a municipal depository – When authorized. If a municipal depository: (i) violates Section 2-32-410(b), or (ii) fails to submit, in a timely manner, the information required under subsection (d) of this section, or (iii) fails to maintain its eligibility to do business with the City under Chapter 1-23 or Section 2-92-320 or other applicable provisions of this Code, the comptroller may decertify the financial institution as a municipal depository if such decertification can be accomplished in a manner consistent with prudent business judgment and sound operating practices.

(f) Acquisition, merger or consolidation – Legal effect on municipal depository designation. If a financial institution that is designated as a municipal depository acquires or is acquired by, or merges or consolidates with, any other financial institution, regardless of whether such other financial institution is a municipal depository, such newly created or successor financial institution shall be deemed, by operation of law, to be a municipal depository as of the date of acquisition, merger or consolidation. Except as otherwise provided in subsections (e) or

(g) of this section, such designation shall remain in effect until ten days after an ordinance designating municipal depositories for the next three-year designation cycle takes legal effect.

(g) *Extension of municipal depository designation for active banks during transition period.* If a municipal depository is an active bank and (i) is not designated by the city council as a municipal depository during the next applicable three-year designation cycle, or (ii) is decertified as a municipal depository pursuant to subsection (e) of this section or otherwise loses or relinquishes its status as a municipal depository, the comptroller shall as soon as reasonably practicable, consistent with prudent business judgment and sound operating practices, transfer the city funds deposited therein to a municipal depository. Until such transfer is completed by the comptroller, such financial institution shall retain its designation as a municipal depository and as an active bank.

(h) *Construction of section.* Nothing in this section shall be construed to prohibit any financial institution, or newly created or successor financial institution, or financial institution that has been decertified as a municipal depository pursuant to subsection (e) of this section, from submitting a bid seeking designation as a municipal depository during the open window or to prohibit the city council from awarding such bid.

SECTION 3. Chapter 2-32 of the Municipal Code of Chicago is hereby amended by inserting, in correct numerical order, a new Section 2-32-400, underscored as follows:

2-32-400 Definitions.

As used in this Article V, unless the context clearly indicates otherwise:

“Active bank” means a municipal depository that has been designated by the comptroller as an active bank pursuant to Section 2-32-480.

“Federally insured” means insured under the Federal Deposit Insurance Act.

“Financial institution” means a regularly organized and federally insured national or state bank or federal or state savings and loan association and/or any federally insured branch of such bank or association that offers loans or provides other banking services to the City or to its residents or businesses.

“Municipal depository” means any financial institution designated by the city council as a legal depository for the funds of the City of Chicago and the Chicago Board of Education as set forth in Section 2-32-405(a)(1).

“Newly created or successor financial institution” means any financial institution or subsidiary thereof created as a result of an acquisition by, or merger or consolidation with, another financial institution.

“Open window” means the period for submitting bids as set forth in an advertisement for bids under Section 2-32-405(a)(1).

SECTION 4. Section 2-32-410 of the Municipal Code of Chicago is hereby amended by deleting the language stricken through and by inserting the language underscored, as follows:

2-32-410 Federal insurance required.

(a) ~~In advertising for bids from regularly established banks and savings and loan associations for interest upon funds to be deposited in such banks or savings and loan associations~~ from financial institutions seeking to be municipal depositories, it shall be the duty of the comptroller to inform the prospective bidders that, for the protection of the public interest, awards ~~will~~ shall be made only to federally insured ~~national and state banks, and to federally insured federal and state savings and loan associations located in the City of Chicago~~ financial institutions.

(b) If a financial institution is designated as a municipal depository under this Article V, the directors or officers of such financial institution, regardless of nomenclature, shall have a duty to provide prompt written notification to the comptroller and treasurer of any change in such financial institution’s status as a federally insured entity under the Federal Deposit Insurance Act. The absence of such federal insurance or the failure to provide the notification required under this subsection (b) may result in decertification of the financial institution as a municipal depository in accordance with Section 2-32-405(e).

SECTION 5. Section 2-32-420 of the Municipal Code of Chicago is hereby amended by deleting the language stricken through and by inserting the language underscored, as follows:

2-32-420 Time deposits – Certificates of deposit.

It shall be the duty of the comptroller to ~~ask~~ advertise for special bids for the payment of interest upon time deposits and/or certificates of deposit of city and school City of Chicago and Chicago Board of Education funds as set forth in Section 2-32-405(a)(1).

SECTION 6. Chapter 2-32 of the Municipal Code of Chicago is hereby amended by inserting a new Section 2-32-425, underscored as follows:

2-32-425 Notifications, statements, and other information – Required.

It shall be the duty of the comptroller to obtain, with each bid to be a municipal depository and in connection with the post-designation annual disclosure required under subsection (d) of Section 2-32-405(d), the following information, which the financial institution shall also provide to the treasurer when submitting such bid or disclosure:

(1) a current and complete City of Chicago Economic Disclosure Statement and Affidavit (“EDS”). Provided, however, that in connection with the post-designation annual disclosure required under Section 2-32-405(d), the financial institution shall provide a written notification identifying any changes to the EDS submitted pursuant to Section 2-32-405(a)(1);

(2) a written statement indicating whether the financial institution is insured under the Federal Deposit Insurance Act;

(3) a complete copy of the financial institution’s United States Securities and Exchange Commission Form 10-K, including financial statements, financial statement schedules, exhibits, and all other papers and documents filed as a part thereof, or, if the financial institution is not required to file Form 10-K with the Securities and Exchange Commission, a document containing similar information;

(4) the number of persons employed by the financial institution at all of its Chicago locations, and the number of women and members of minority groups, as defined in Section 2-92-420(r), at those locations;

(5) if the financial institution is currently a municipal depository, the number of employees dedicated or assigned to work on the city’s municipal depository account(s), and the number of women and members of minority groups, as defined in Section 2-92-420(r), dedicated or assigned to such accounts;

(6) a statement of community involvement, describing the financial institution’s economic development programs, if any; and identifying any cultural, educational, health, social service, civic, community or similar beneficial contributions made by the financial institution or by its directors or officers to the community that the financial institution serves;

(7) the amount, in dollars, of credit support provided by the financial institution to the city for: (1) variable rate bonds and notes issued by the city and its sister agencies (e.g. letters of credit, lines of credit, direct purchase), and (2) derivatives (e.g. swaps and options), and (3) investment vehicles (e.g. forward purchase agreements and guaranteed investment contracts); and

(8) if applicable, a copy of: (i) the most recent report that the financial institution is required to provide annually to the United States Comptroller of the Currency under the

Community Reinvestment Act; and (ii) the most recent evaluation performed by the United States Comptroller of the Currency of the financial institution's performance under the Community Reinvestment Act.

SECTION 7. Section 2-32-430 of the Municipal Code of Chicago is hereby amended by deleting the language stricken through and by inserting the language underscored, as follows:

2-32-430 Statements of resources and liabilities.

It shall be the duty of the comptroller to obtain, with each bid ~~for interest upon city and school funds to be a municipal depository,~~ copies of the last two sworn statements of resources and liabilities of the bidding ~~bank or savings and loan association~~ financial institution as reported to the state or federal authority charged with the supervision of such ~~banks or savings and loan associations and~~ financial institution. The financial institution shall also provide such copies to the treasurer when submitting its bid. It shall be the duty of the comptroller to present said statements to the city council with such bid. When requested to do so by the city council, the comptroller shall obtain, from time to time from the ~~banks and savings and loan associations~~ financial institutions to which awards are made, copies of all reports of conditions made in response to the regular calls for such reports by the state and federal authorities. ~~Together~~ If the financial institution submitting a bid is a savings and loan association, the comptroller shall require, in addition to such ~~with the receipt of bids and sworn statement of resources and liabilities, as aforesaid, the comptroller shall require of savings and loan associations submitting bids~~ such reports, data and information as to the bidder's financial stability of the bidder as will that the comptroller determines are necessary or appropriate to assist the comptroller in determining its such bidder's compliance with standards promulgated by resolution of the city council for savings and loan depositories.

SECTION 8. Section 2-32-440 of the Municipal Code of Chicago is hereby amended by deleting the language stricken through and by inserting the language underscored, as follows:

2-32-440 Lending and deposit specifications required.

With each bid ~~for interest upon city and school funds to be a municipal depository,~~ the comptroller shall obtain, ~~in a form prescribed by him~~ from each bidder, in a form prescribed by the comptroller, the lending and deposit information set forth in subsections (a) through (f) of this section for its such bidder's home office and for each branch office or facility ~~the following information.~~ The financial institution shall also provide the information required under this section to the treasurer when submitting its bid.

(Omitted text is unaffected by this ordinance)

~~(e)~~ ~~Community Reinvestment Act information. A copy of the most recent evaluation performed by the United States Comptroller of the Currency of each bidder's performance under the Community Reinvestment Act, as amended. The city comptroller shall transmit copies of all evaluations received to the city council with the report of bids required by Sections 2-32-400 of this Code.~~

~~(f)~~(e) *Optional.* Each bidder may submit such additional material that is deemed relevant to consideration of the bid.

~~(g)~~(f) *Additional residential loan information.* In addition to the information required in subdivision (a) of this section and the pledge required in Section 2-32-455, the following information is to be reported concerning residential loans made by the bidder and its affiliates on dwellings that are for not more than four families or that are condominium or cooperative units:

(Omitted text is unaffected by this ordinance)

SECTION 9. Section 2-32-450 of the Municipal Code of Chicago is hereby amended by deleting the language stricken through and by inserting the language underscored, as follows:

2-32-450 Loan policy – Pledge requirements.

With each bid ~~for interest upon city and school funds to be a municipal depository,~~ the comptroller shall obtain the signature by either the chairman of the board, chief executive officer, or an officer acceptable to the city comptroller, of the bidding ~~bank or savings and loan association~~ financial institution on the following pledge:

(Omitted text is unaffected by this ordinance)

SECTION 10. Section 2-32-455 of the Municipal Code of Chicago is hereby amended by deleting the language stricken through and by inserting the language underscored, as follows:

2-32-455 Predatory lenders.

(a) No financial institution may be designated as a city municipal depository if it or any of its affiliates has been determined by the chief financial officer or the city comptroller to be a predatory lender. Every financial institution shall, prior to any such designation, submit to the city a pledge affirming that neither it nor any of its affiliates is or will become a predatory lender within the City of Chicago. The pledge shall be signed by the chairman of the board, chief executive officer or other officer of the financial institution acceptable to the chief financial officer or the city comptroller. The pledge shall be in substantially the following form:

(Omitted text is unaffected by this ordinance)

SECTION 11. Section 2-32-470 of the Municipal Code of Chicago is hereby amended by deleting the language stricken through and by inserting the language underscored, as follows:

2-32-470 Daily deposit of city funds.

No money shall be deposited in any ~~bank or savings and loan association~~ financial institution unless and until it the financial institution has been designated by the city council as a ~~depository~~ municipal depository. The city treasurer shall deposit, daily, all monies received by ~~him as the city treasurer,~~ during the banking hours on each such day and all ~~such~~ monies ~~as he may have received by the city treasurer on the day previous~~ after banking hours on the previous day, in ~~one of the banks or savings and loan associations which may have a financial institution that has been designated by the city council as depositories~~ a municipal depository pursuant to law this Article V and designated by the comptroller as an active bank pursuant to Section 2-32-480.

SECTION 12. Section 2-32-480 of the Municipal Code of Chicago is hereby amended by deleting the language stricken through and by inserting the language underscored, as follows:

2-32-480 Active banks – Designation authority – Qualifications.

The comptroller may designate, from time to time, and for such period of the fiscal year as ~~he the comptroller~~ deems advisable and for in the best interests of the city, one or more ~~of the depositories~~ municipal depositories selected in accordance with law as an active ~~bank or active banks~~ bank(s), and to rescind any such ~~selection or selections~~ designation(s) at any time when, in ~~his the comptroller's judgment,~~ such change should be made, but Provided, however, that no ~~bank~~ municipal depository shall be ~~selected~~ designated by the comptroller as an active bank unless its aggregate capital stock and surplus at the time it is ~~accepted~~ designated as a ~~city depository~~ an active bank is \$500,000.00 or more.

SECTION 13. Section 2-32-490 of the Municipal Code of Chicago is hereby amended by deleting the language stricken through and by inserting the language underscored, as follows:

2-32-490 Active banks – Use by treasurer – School funds.

During the period for in which any ~~such depository of city and school funds~~ municipal depository shall be is designated as ~~the an~~ active ~~bank~~ bank(s) under ~~the provisions of~~ Section 2-32-480, the treasurer shall deposit all monies received by ~~him~~ the treasurer in such active ~~bank~~ bank(s) and shall draw ~~his~~ checks upon such active ~~bank~~ bank(s) to pay warrants drawn upon ~~him~~ the treasurer.

School funds may be deposited in any ~~such bank~~ active bank(s) in an account separate from city accounts and the title of the accounts so established shall appropriately describe the same as school funds.

SECTION 14. Section 2-32-500 of the Municipal Code of Chicago is hereby amended by deleting the language stricken through and by inserting the language underscored, as follows:

2-32-500 Interest payments on city funds – Report requirements.

The treasurer shall make a monthly report, to the comptroller, under oath, for each calendar month, of all interest monies received by or credited to the treasurer or to the city by any ~~depository~~ municipal depository in which is ~~deposited~~ any interest-bearing monies of the city are deposited, including trust funds and special deposits.

Such report shall show (1) the name of the ~~depository~~ municipal depository where any interest-bearing monies are deposited, (2) the average sum of money on deposit in each ~~depository~~ municipal depository during the applicable calendar month, (3) the interest paid or credited ~~thereon on such monies~~ by each ~~depository~~ municipal depository, and (4) the average rate of interest so paid or credited.

Such report shall ~~be~~ be made and verified to the comptroller on or before the fifth day of the month next succeeding the month for which the report is rendered.

SECTION 15. Section 2-32-510 of the Municipal Code of Chicago is hereby amended by deleting the language stricken through and by inserting the language underscored, as follows:

2-32-510 Interest on school funds.

The treasurer shall place to the credit of the school fund all interest that may be earned ~~thereby thereon and be~~ received by ~~him~~ the treasurer.

SECTION 16. Section 2-32-575 of the Municipal Code of Chicago is hereby amended by deleting the language stricken through and by inserting the language underscored, as follows:

2-32-575 Lending securities.

(a) The comptroller and city treasurer jointly may lend securities in the city treasury to a borrower upon such terms and conditions as may be mutually agreed in writing. Such agreement shall provide that during the period of the loan the city shall retain the right to receive, or collect from the borrower, all dividends, interest rights, or any distributions to which the city

would have otherwise been entitled. The transfer of the securities shall be through a lending agent which is an approved municipal depository pursuant to Section ~~2-32-400~~ 2-32-405.

(Omitted text is unaffected by this ordinance)

SECTION 17. The following national and state banks and federal and state savings and loan associations have been designated municipal depositories of the City of Chicago and of the Chicago Board of Education for the purpose of holding and paying interest on municipal deposits, and each such financial institution has on file with the City Comptroller the information required under Sections 2-32-430, 2-32-440 and 2-32-450 of the Code:

Associated Bank; N.A.;
First Merit Bank, N.A.; and
MB Financial Bank, N.A.

SECTION 18. The financial institutions listed in SECTION 17 of this Ordinance are hereby designated as legal depositories for the City of Chicago and Chicago Board of Education for Fiscal Year 2015, and the Treasurer of the City may deposit monies received by him in any of these institutions in accordance with Sections 2-32-470, 2-32-480 and 2-32-490 of the Code. Notwithstanding any Code provision to the contrary, this designation shall remain in full force and effect from and through the date set forth in SECTION 19 of this Ordinance.

SECTION 19. If the City Council adopts an ordinance under Article V of Chapter 2-32 of this Code designating municipal depositories, and such ordinance takes effect in calendar year 2015, such designation shall: (1) apply from the date in 2015 that the designation takes legal effect; and (2) except as otherwise provided in subsections (c), (e) or (g) of Section 2-32-405, remain in effect until ten days after the three-year designation cycle for municipal depositories that begins on January 1, 2016 ends.

SECTION 20. To the extent that any ordinance, resolution, rule, order or provision of the Code, or part thereof, is in conflict with the provisions of this Ordinance, the provisions of this Ordinance shall control. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any other provision of this Ordinance.

SECTION 21. This ordinance shall take full force and effect upon its passage and approval.

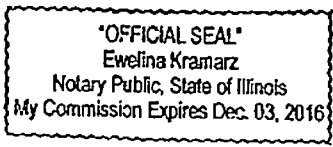




