ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single Unit Detached House District symbols and indication as shown on Map No. 7-J in the area bounded by

A line 75.00 feet north of and parallel to the public alley next north of Fullerton Avenue; North Hamlin Avenue; the northerly right-of-way line of the public alley next north of Fullerton Avenue; and the public alley next west of North Hamlin Avenue.

To those of C1-1 Commercial Neighborhood District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
