BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Section 3-56-050 of the Municipal Code of Chicago is hereby amended by inserting the language underscored and deleting the language struck-through, as follows:
