ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 14-H in the area bounded by:

A line 67 feet North of and parallel to West 58th Street; South Damen Avenue; West 58th Street; the public alley next West of and parallel to South Damen Avenue.

To those of a C2-1, Motor Vehicle-Related Commercial District

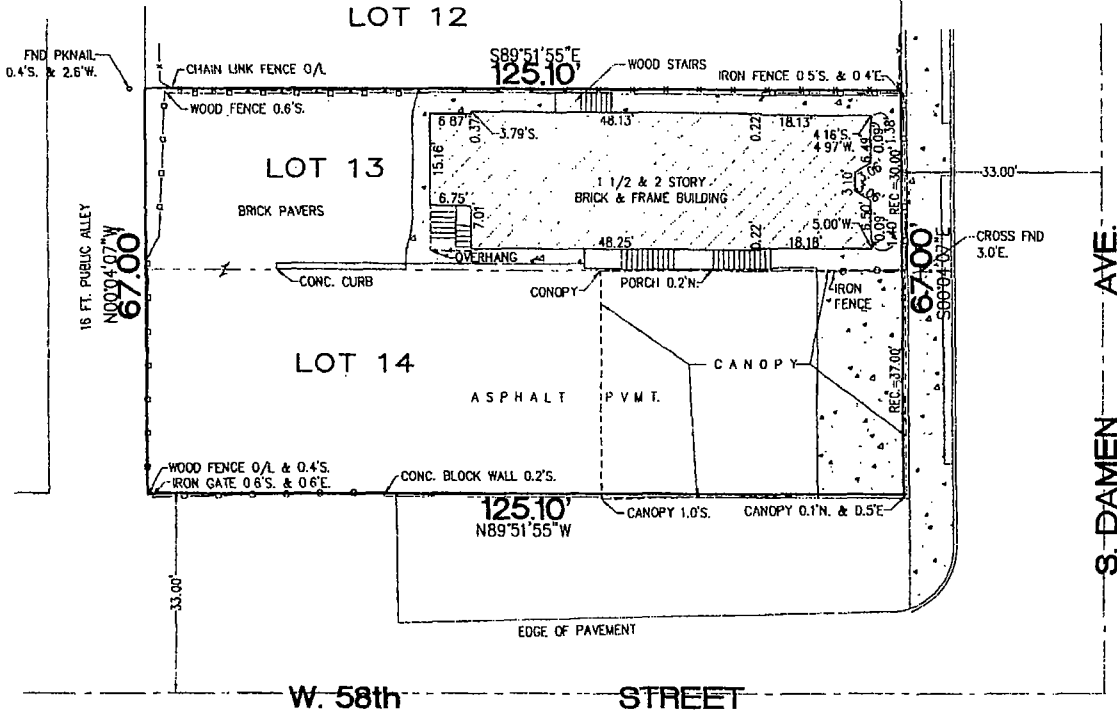
SECTION 2. This Ordinance takes effect after its passage and due publication.





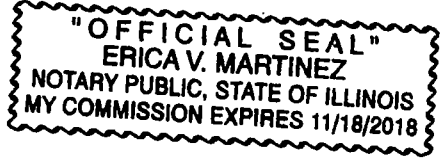
