ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B1-1, Neighborhood Shopping District symbols as shown on Map No. 7-L

in the area bounded by:

A line 216.37 feet North of and parallel to West Wrightwood Avenue; North Cicero Avenue; West Wrightwood Avenue; the public alley next West of and parallel to North Cicero Avenue.

To those of a C1-1, Neighborhood Commercial District

SECTION 2. This Ordinance takes effect after its passage and approval.
